- How Do I Apply?**
1. Complete one application per family/household and drop off at Reception at:
 - SEAPARC Recreation Centre • 2168 Phillips Rd, Sooke BC • Phone: 250.642.8000
 2. Bring identification such as Care Card, BC ID, Drivers License
 3. Bring current proof of residency for each adult applicant, such as a utility bill, rental agreement or government ID.
 4. Bring previous year's Notice of Assessment listing line 15000 for each adult applicant as proof of combined gross annual household income. To obtain a copy of your NOA call Revenue Canada at 1-800-959-8281 or visit <http://www.cra-arc.gc.ca/myaccount>
 5. LIFE Cards will be issued to each member of an eligible family and are valid for one calendar year: January 1, 2024 - December 31, 2024.

Your application will be reviewed and you will be notified within 2 weeks from the date received of approval or not.

CHOOSE ONE OF THE FOLLOWING DISCOUNTS

Option 1 Drop-in and Registration Discount

- 52 Free Admissions to Drop-in Sessions at any Greater Victoria Recreation Centre (incl. SEAPARC, West Shore, Esquimalt, Saanich, City of Victoria, Oak Bay and Panorama Recreation Centres).
- Program subsidy of \$125/child and \$75/adult, limited to \$50 per program. The program subsidy can be applied to SEAPARC programs only.
- Should you use your 52 visits before year end, you may use your program subsidy (up to \$50/transaction) to purchase a 10 Visit or 1 Month Active Pass to be used at SEAPARC Recreation Centre.

One card is issued once per year for each family member. LIFE card must be presented at the time of admission.

Option 2 Annual Pass 50% Discount - SEAPARC Annual Pass

- Rates with Discount Applied: Child/Youth \$102, Adult/Senior \$205, Family \$410
- Monthly payment plan available with a \$25 admin fee: Visa, MasterCard, Cheque accepted
- Unlimited access to all drop-in programs (SEAPARC Recreation Centre & satellite locations only)

Option 3 Annual Pass 50% Discount - Annual Regional Pass

- Receive this \$552 pass for \$276 (monthly payment plan available with a \$25 admin fee: Visa, MasterCard, Cheque accepted)

Unlimited access to all drop-in programs at 14 Greater Victoria Recreation Centres (does not include YMCA-YWCA).

Additional Information:

- LIFE cards are non-transferable, and are not eligible for cash or credit
- Participants must have their picture taken for their LIFE card
- \$5 + tax replacement charge for lost cards
- Replacement cards will be provided by subtracting 4 visits a month from January up to date card is replaced
