CRITERIA AND DEFINITION

Applicant **MUST BE** a resident/property owner on Mayne Island, or one of the Southern Gulf Islands within the Capital Regional District South Gulf Island Electoral Area to be eligible for consideration.

As defined in Capital Regional District Bylaw No.2844 (Consolidated) - South Gulf Islands Small Craft Harbours Regulations:

"Southern Gulf Islands Electoral Area" means the area of land defined as the Southern Gulf Islands Electoral Area in the Capital District Letters Patent.

"PROOF OF RESIDENCY" means:

- a) a British Columbia driver's license containing an address in the Southern Gulf Islands Electoral Area; or
- b) a real property tax notice issued under the Local Government Act or the Taxation (Rural Area) Act to an address in the Southern Gulf Islands Electoral Area; or
- c) a utility bill issued for the supply of electricity, natural gas, water, telephone services or co-axle cable services to an address in the Southern Gulf Islands Electoral Area.

"resident" means a person who satisfies the conditions of residency established in section 67 of the Local Government Act in respect of the Southern Gulf Islands Electoral Area.

- □ Proof of vessel's license/registration
