What is L.I.F.E.?

L.I.F.E. (Leisure Involvement for Everyone) is for individuals and families with a limited income.

Who Qualifies for L.I.F.E.?

Individuals and families whose income is within or below the Statistics Canada Low Income Cut Off levels Applicant families/individuals must live within Sooke and the Electoral Area.

- University and college students are not eligible for L.I.F.E.
- All applicants must be Canadian citizens.

What Do You Get From L.I.F.E.?

Each family member (over the age of 6) will receive 52 free admissions to use for any regularly priced drop in activities at SEAPARC and all other recreation centers in the Greater Victoria area. These admissions are applicable for swimming, skating, aerobics, aquafit and weight rooms.

Each family member will also receive 4 program discounts per year (1 per season), for use at SEAPARC. These discounts apply only to SEAPARC programs and some restrictions apply.

How to apply:

Complete the application form (include all family members living in the household). Post secondary students and exchange students are not eligible.

Bring the completed application form to the SEAPARC Leisure Complex. **All applications must be accompanied by a copy of the latest Notice of Assessment from Revenue Canada for each adult living in the household.** Identification must be provided at this time for all people on the application form.
