

CRD Arts Development Service Arts Advisory Council Members (Updated Oct 2017)

The Capital Regional District (CRD) Board established the Arts Advisory Council (AAC), an arms-length third party to adjudicate arts grants requests and recommend organizational grant awards to the Arts Commission. The AAC also advises the Commission on policy for support programs and facility development for the arts within the region, as well as municipal arts policies that serve as a catalyst in the enlargement and enrichment of the cultural life of the community.

BILL CROOK

Mr. Crook has a wealth of experience leading national and provincial organizations in the arts, amateur/professional sport, recreation and disability sectors. He has served as General Manager for Presentation House Theatre in North Vancouver, General Manager of Manitoba Theatre for Young People, Executive Director of the Prince Edward Island Arts Council, and Associate Director and Executive Director with the Rick Hansen Foundation. In addition, Bill has held senior positions within the amateur sports field, including General Manager for two Western Canada Summer Games (1990, Winnipeg & 1995, Abbotsford) and Director Sport for the Province of Manitoba. As a volunteer, he served on the board of the East Coast Music Association, Manitoba Theatre for Young People, the Mission Folk Festival, and the Prince Edward Island Storytelling Festival. He currently volunteers with the Sidney Lawn Bowling Club. Bill maintains a keen interest in music, theatre for young people, year-round outdoor swimming and long-distance walking. While he has lived in many provinces across Canada, as well as in the UK, for the past 13 years he has been proud to call Vancouver Island home.
