PARK USE PERMIT FEES AND CHARGES PAYABLE FOR REGIONAL PARKS  
SERVICES AND FACILITIES WITHIN THE CAPITAL REGIONAL DISTRICT**

The Board of the Capital Regional District, in open meeting assembled, enacts as follows:

1. Bylaw No. 3675, "Capital Regional District Regional Parks Services and Facilities Fees and Charges Bylaw No.1, 2010", is amended as follows:  
  
By deleting Schedule "A" in its entirety and replacing it with the attached Schedule "A".
2. The fees and charges established under this Bylaw shall come into effect on May 1, 2013.
3. This Bylaw may be cited as, "Capital Regional District Regional Parks Services and Facilities Fees and Charges Bylaw No.1, 2010, Amendment Bylaw No. 3, 2013".
