### CAPITAL REGIONAL DISTRICT BYLAW NO. 376

***************************************
A BY-LAW TO IMPOSE BULK WATER RATES
***************************************

WHEREAS by Supplementary Letters Patent issued the 22nd December 1976, the Capital Regional District Board was granted the function of water supply for the area comprised of all lands within the boundaries of the Corporation of the District of Central Saanich, the District of North Saanich and the Town of Sidney;

AND WHEREAS the Regional District is empowered by bylaw to fix rates and charges for the supply of water to the said municipalities for distribution only within their municipal boundaries except with the consent of the Regional District;

AND WHEREAS on the recommendation of the Saanich Peninsula Water Commission, a Commission established pursuant to the provisions of the said Supplementary Letters Patent, the Regional District is to commence as of 1st June 1977, or as soon thereafter as is reasonably possible, supplying and billing the said municipalities for all water consumed within their municipal boundaries;

NOW THEREFORE the Capital Regional District Board in open meeting assembled, enacts as follows:

- 1. The rates set out in Schedule "A" are applicable to all water supplied in bulk to each of the three participating member municipalities of North Saanich, Central Saanich and Sidney and to be used for distribution only within their respective municipal boundaries except with the consent of the Regional District Board.
- 2. Bulk water supplied to each participating member municipality shall be recorded by meters installed at each point of connection of a municipal distribution system to the District supply system.
- 3. Billings for water supplied shall be made monthly and shall be payable without penalty within thirty days of the date of the date of billing.
- 4. Aten per cent penalty shall be imposed on all billings remaining unpaid as of the due date.
- This by-law shall not come into force and effect until it has received the approval of the Lieutenant-Governor in Council.
- 6. This By-law may be cited as "Bulk Water Rates By-law, 1977"

#### **SCHEDULE "A"**

(Bylaw 4579)

For each cubic metre of water supplied to the District of Central Saanich, the District of North Saanich and the Town of Sidney, the rate of \$1.1978 is effective January 1, 2024.

For each cubic metre of water supplied to the Department of Agriculture Research Station, located at 8801 East Saanich Road, Sidney, BC, the rate of \$1.2330 is effective January 1, 2024.
