**A BYLAW TO AMEND BYLAW 2538, BEING “WATER DISTRIBUTION LOCAL SERVICE  
AREA ESTABLISHMENT BYLAW NO. 1, 1997.”**  
\*\*\*\*\*

WHEREAS:

- A. Under Section 2 of the *Capital Region Water Supply and Sooke Hills Protection Act*, S.B.C. Chap. 5 (the “Act”), the Capital Regional District was required to adopt a bylaw that met all the requirements for a bylaw under section 800.1(1) of the *Local Government Act* , and which included all or part of each of the initial participating areas;
- B. The Capital Regional District adopted Bylaw No. 2538 cited as “Water Distribution Local Service Area Establishment Bylaw No. 1, 1997 ”;
- C. The Capital Regional District Board wishes to provide water service to that part of the District of Highlands as outlined on Schedule “B” annexed hereto;
- D. The bylaw must be approved by the Minister of Community Services under section 3(6) of the Act;
- E. Section 801(1)(b) and (2) of the *Local Government Act* requiring assent of the electors or consent on their behalf does not apply to this bylaw.

NOW THEREFORE, the Board of the Capital Regional District in open meeting assembled enacts as follows:

- 1. Bylaw No. 2538, “ Water Distribution Local Service Area Establishment Bylaw No. 1, 1997 ” is amended :
  - (a) by deleting section 2 and replacing it with the following,  

"The boundaries of the water distribution service area are contiguous with the boundaries of the participating areas listed in Section 3 and that part of the District of Highlands shown outlined on Schedule 'B'.",
  - (b) by amending Section 3 to add "District of Highlands" after "District of Sooke", and
  - (c) by adding Schedule B.

**Bylaw 3373**

2. This Bylaw may be cited for all purposes as the “Water Distribution Local Service Area Establishment Bylaw No. 1, 1997, Amendment Bylaw No. 3, 2006”.

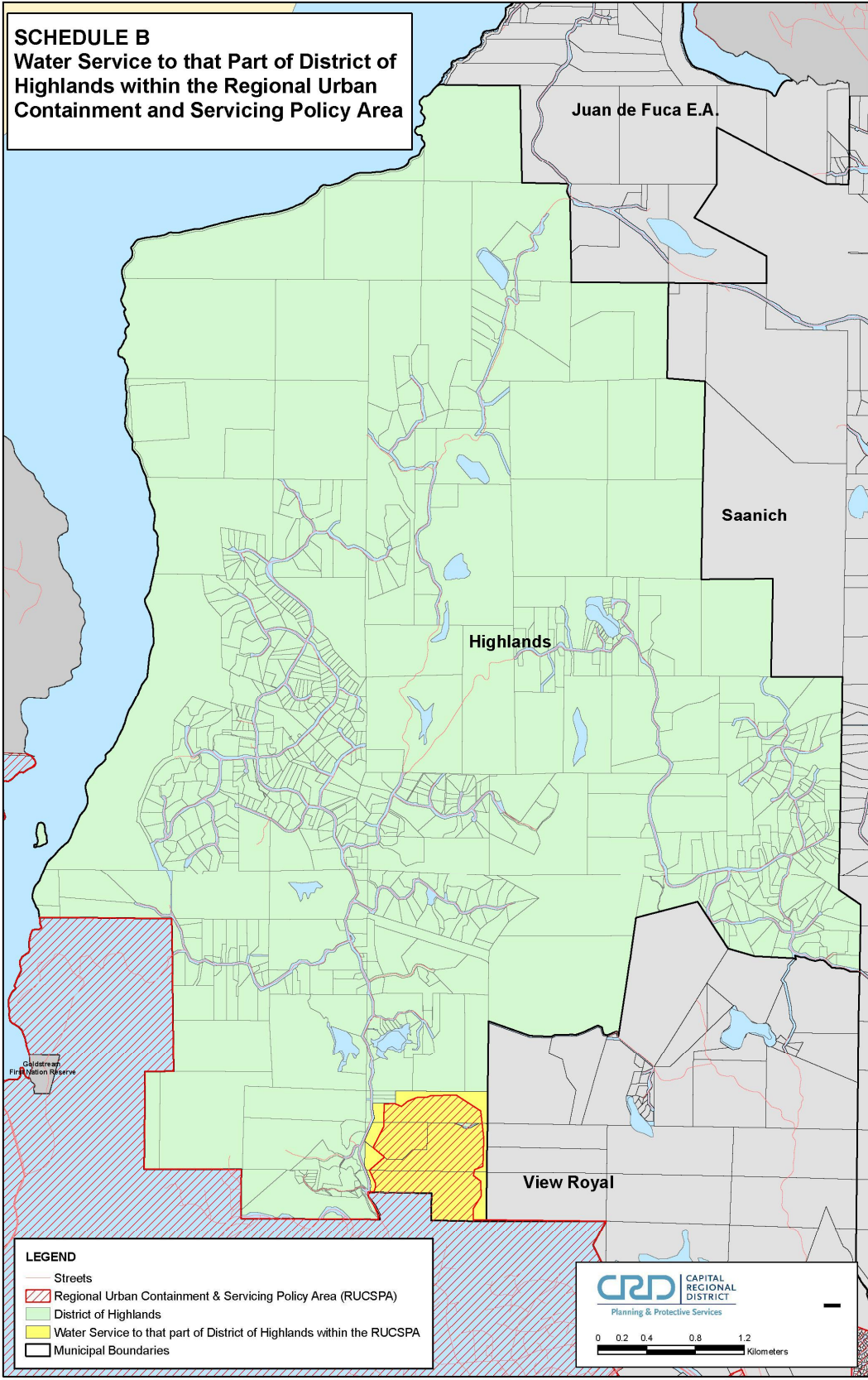
