



**REPORT TO CORE AREA LIQUID WASTE MANAGEMENT COMMITTEE
MEETING OF WEDNESDAY 24 NOVEMBER 2010**

SUBJECT **TRUCKED LIQUID WASTE PROGRAM FIVE-YEAR PLAN – 2011-2015**

ISSUE

To present the Trucked Liquid Waste Program five-year plan (2011-2015) to the Core Area Liquid Waste Management Committee.

BACKGROUND

At the 22 September 2010 Core Area Liquid Waste Management Committee meeting, staff presented the 2009 annual report *Trucked Liquid Waste Program* and a separate independent executive summary five-year program review (2004-2008). The purpose of the Trucked Liquid Waste Program (TLWP) is to educate generators and service providers to ensure trucked liquid waste is handled and disposed of in an appropriate and responsible manner to protect human health and the environment.

The committee directed staff to bring back a five-year plan (2011-2015) for the program in November 2010, attached as Appendix A. The plan incorporates recommendations from the review and places new focus on catch basin waste management, identifying trucked liquid wastes that may be a resource, and on working with municipal and senior governments.

ALTERNATIVES

1. That the Core Area Liquid Waste Management Committee approve the five-year plan for the Trucked Liquid Waste Program (2011-2015) as presented; or
2. That the Core Area Liquid Waste Management Committee:
 - (a) receive the report for information; and
 - (b) direct staff to amend the plan and bring it back to the committee in early 2011.

FINANCIAL IMPLICATIONS

The 2010 budget for the TLWP is \$50,210. No increase in the program budget is projected as a result of the five-year plan.

CONCLUSION

Staff have developed a five-year plan for the Trucked Liquid Waste Program (2011-2015) incorporating recommendations from the independent five-year program review.

RECOMMENDATION

That the Core Area Liquid Waste Management Committee approve the Trucked Liquid Waste Program five-year plan as presented in Appendix A.
