**Minutes of a Meeting of the Core Area Wastewater Treatment Program Commission

1. Approval of Agenda

5. Supply of Pumps, Drives and Motors for Craigflower Pump Station Award of Contract – RFP No. CF-003 (CAW 13-05)

J. Hull spoke to the report. The Commission discussed the evaluation of the proposals and the experience of the recommended supplier.

That the Core Area Wastewater Treatment Program Commission award contract CF-003 for the supply of pumps, drives and motors for Craigflower pump station to KSB Pumps Inc. in the amount of \$510,841.97.

6. Approval of Communications Consultant Contract (CAW 13-04)

J. Hull spoke to the report. The Commission discussed the following topics:

- The objectives of the communications consulting services
- Contract details related to the initial scope and future definable services
- The initial assignment of a strategic communications plan

That the Core Area Wastewater Treatment Program Commission approve Acumen Communications as the Communications Consultant to prepare a Strategic Program Communications Plan in the amount of \$17,475 plus GST, and to provide ongoing services as requested until November 1, 2013.
