A Incidents.

We have had 6 call outs since my last report:

- 2 MVIs. It needs to be pointed out that although cars are capable of driving very fast, our roads are not.

- 1 First response call. My heartfelt condolences go out to his surviving family members and friends.
- 1 Mutual aid with Metchosin fire.
- 1 small house fire. A cake's candles ignited the surroundings, Occupants were concerned about the possible ill effects of the dry chemical fire extinguishing agent; and
- 1 tree across road and onto hydro lines.

We currently have 24 fire fighters: 4 new recruits, 1 administrative assistant, and 19 regular firefighters.

**C** Training.

Thursday training has been attended by an average of 14 personnel.

Tuesday Training has been attended by an average of 7 personnel.

Training has included IFSTA modules #1, 2 and 5, and First responder training.

**D** Business.

This year's Halloween festivities went off well. The brigade put on a fireworks display, bonfire, hot dogs and hot chocolate and East Sookes traditional "Candy line". Lieutenant Lindsay Trowell recruited many of the fire fighters to assist in the assembly and manning of her "Eerie Acres" haunted house where she transformed her home and yard into a very impressive display of terrifying scenes. Entry was by donation. 4 bins of food donations went to the Sooke food bank and \$450.00 was given to a family whose daughter has leukemia to assist with their transportation costs.

We have received many comments and phone calls expressing appreciation for the huge output of time, effort and expense that the brigade gives to the community to make our Halloween a successful event every fall.
