

REPORT TO ELECTORAL AREA SERVICES COMMITTEE MEETING OF WEDNESDAY, 21 MARCH 2012

SUBJECT

FEES AND CHARGES UPDATE FOR UTILITIES WITHIN THE THREE ELECTORAL AREAS

ISSUE

The fees and charges for utilities within the three Electoral Areas need to be updated.

BACKGROUND

The proposed fees and charges increases are based on the 2012 budget review and have been factored into the 2012 service budgets. The first quarter billing for 2012 is scheduled for invoicing the second week of April. The proposed rates require Board review and approval prior to taking effect in the billing process.

ALTERNATIVES

- 1. a) That Bylaw No. 3822, cited as "Salt Spring Island Liquid Waste, Sewer, and Water Fees and Charges Bylaw No. 1, 2010, Amendment Bylaw No. 3, 2012" be introduced and read a first and second time, read a third time and adopted.
 - b) That Bylaw No. 3823, cited as "Southern Gulf Islands and Juan de Fuca Electoral Areas Utilities and Street Lighting Fees and Charges Bylaw No. 1, 2011, Amendment Bylaw No. 2, 2012" be introduced and read a first and second time, read a third time and adopted.
- 2. That the bylaws be referred back to the local service committees.

IMPLICATIONS

<u>Financial</u>

Fees and charges increases ranging from 3% to 33% are required, due primarily to: the additional debt servicing cost of infrastructure upgrades, deficit carry forward, reduced surplus carry forward, and increased hydro costs. All the related service committees have approved their 2012 budgets which include the proposed increases, except for Fulford and Cedars of Tuam where budget approval is pending and anticipated by March 31, 2012.

Board approval is required prior to applying the proposed rates. If these rates are not approved in time for the 2012 first quarter billing, revenues will be less than forecasted in the 2012 service budgets.

CONCLUSION

Several utilities require fees and charges increases due primarily to: the additional debt servicing cost of infrastructure upgrades, deficit carry forward, reduced surplus carry forward, and increased hydro costs. These increases are factored into the 2012 service budgets which have all received service committee approval except for Fulford and Cedars of Tuam where budget approval is pending and anticipated by the end of March, 2012. Board approval of the proposed rates is required prior to the April 2012 first quarter billing in order to attain the revenue targets in the 2012 service budgets.

 - b) That Bylaw No. 3823, cited as "Southern Gulf Islands and Juan de Fuca Electoral Areas Utilities and Street Lighting Fees and Charges Bylaw No. 1, 2011, Amendment Bylaw No. 2, 2012" be introduced and read a first and second time, read a third time and adopted.

SCHEDULE "B"

1. Water Service Turn On and Turn Off Fee

Pursuant to Section 4, the fee for turning on or turning off the water supply at the curb stop is the following. The fees payable herein shall be paid to the CRD on application for the service.

- (a) During Normal Working Hours (07:30 16:00) Monday through Friday (non-inclusive of statutory holidays): \$50.00
- (b) During Non-Working Hours: \$200.00

2. <u>Water and Sewer User Fees</u>

The user fees payable shall include a fixed fee and a variable consumption charge based on the volume of water metered as outlined below:

(a) Fixed Fee

(b) Consumption Charge based on volume of water metered

The Consumption Charge for water or sewer will be the total volume of water metered to the water service connection, measured in cubic metres (or other units converted to cubic metres) over a three-month billing period, at a rate as follows:

1. Water, Sewer, and Port Renfrew Street Lighting

a) For Single Family Equivalent, the user fees payable by Service Area shall be:

Wilderness Mountain Water	Consumption Charge: \$18.00 per month for each Single Family Equivalent connected to the water system. Annual User Charge: \$558.81 per annum for each Single Family Equivalent connected to the water system.
Port Renfrew Water Annual User Charge	\$203.38 per Unit (see Section 1b) billed in four equal payments
Port Renfrew Sewer Annual User Charge	\$413.88 per Unit (see Section 1b) billed in four equal payments
Port Renfrew Street Lighting	\$39.19 per User

b) For other Consumers, the annual charge, 25% of which is billed each three months, is calculated as "N" times the total annual Single Family Equivalent. "N" is determined as outlined in the following chart, except as noted in Sections 1c and 1d.
