

# REPORT TO THE ELECTORAL AREA SERVICES COMMITTEE MEETING OF WEDNESDAY, JUNE 20, 2012

SUBJECT: RAINBOW ROAD INDOOR POOL OPERATING CONTRACT FOR THE FIVE (5) YEAR PERIOD APRIL 1, 2013 TO MARCH 31, 2018

## ISSUE

The operating contract for the Rainbow Road Indoor Pool expires in March 2013.

## **BACKGROUND**

The Rainbow Road Pool on Salt Spring Island is operated by a contractor. Recreation Excellence has operated the pool since its opening in early 2008. The current contract expires March 31, 2013. A Request for Proposals was issued in December 2011with the deadline for submissions being January 31, 2012. Recreation Excellence was the only contractor to submit a proposal.

The current fee for services for Recreation Excellence is \$524,780. The fees identified in the proposed five (5) year contract are as follows:

April 1, 2013 to March 31, 2014	\$550,756
April 1, 2014 to March 31, 2015	\$561,652
April 1, 2015 to March 31, 2016	\$572,767
April 1, 2016 to March 31, 2017	\$584,106
April 1, 2017 to March 31, 2018	\$595,654

#### **ALTERNATIVES**

- 1. Approve the new contract with Recreation Excellence for the five (5) year period April 1, 2013 to March 31, 2018; or
- 2. Advise the contractor that additional changes are to be made to the contract.

#### **IMPLICATIONS**

The increase in the fee for 2013 and onward has been included in the 2012 5-year Financial Plan by Salt Spring Island Parks and Recreation.

# CONCLUSION

A renewal of the SSI Rainbow Road Pool Operating contract has been negotiated and agreed to by the contractor and Salt Spring Island Parks and Recreation Commission.
