# Juan de Fuca Emergency Planning Committee Meeting 1 February 2011 SAR Campus 2028C Idlemore Road Minutes (Corrected)

Call to Order: Meeting was called to order by G. OBriain at 19:02hrs.

Introductions: All present introduced themselves

Regrets: B. Meikle

**Approval of Agenda:** Motion was made by J. Grant and seconded by T. Mehler to accept agenda as presented Motion carried.

Adoption of 4 January 2011 Minutes: The minutes of the 4 January 2011 meeting were presented for approval. Several corrections were given: pg 4: Port Renfrew CC report use "...needs to be resolved." in place of "...is still a problem."

And B. Broster asked that the ESS Report be changed to read "paid for by the JEPP Grant". A motion was made by S. Wright and seconded by T. Mehler to accept minutes with the above corrections.

**Presentations:** There were no presentations.

#### **Old Business:**

- A. Volunteers for Critical Positions: G. OBriain reminded all attendees that he needs help getting these critical volunteers positions filled.
- B. Volunteer Appreciation Dinner: 17 people attended the Volunteer Appreciation Dinner and enjoyed themselves a lot.
- C. Emergency Community Containers:
  - i) Shelving: The shelving for the Malahat Container is ready to be picked up. T. Dixon said that he would pick up the shelving very soon.
  - ii) Balancing of equipment in containers: G. OBriain still needs the inventories of the Port Renfrew and Malahat emergency containers.
  - iii) New supplies for pickup: G. OBriain has additional supplies for the Malahat and Otter Point emergency containers and would appreciate if these are picked up from his truck this evening following the meeting.

#### D. ShakeOut BC:

- i) Update: 400,000 people registered to participate. This was apparently well received throughout BC. It had national TV and radio coverage.
- Post Exercise Wrap-up: B. Webb stated that there was good turnout in the radio room. They had CB radio traffic with all Sooke schools. However it was noted that those using the CB radios in the schools had no experience with the use of CB radios and it was suggested that there be training and familiarization with speaking on radios. It was noted that there is a need for trained radio operators in all the Juan de Fuca communities to talk on the radio. There was no one from Otter Point, Port Renfrew, or East Sooke to talk on the radio during the exercise. J. Grant was in the EOC for the exercise and found that the lack of computers was probably very realistic as to what would be the situation in such an event. She stated that she found all the boxes to be unorganized, and the appropriate forms were difficult to find. She requested that there be a meeting of EOC volunteers so that all boxes could be reorganized. R. McLeod stated that as far as communications with the schools went, the people operating the radios at the schools had no idea how to operate said radios. Chief Sorensen had wanted to have a tabletop exercise downstairs at the Fire Hall but this was unable to happen. T. Mehler stated that there was not much interest in ShakeOut BC in Port

Renfrew outside of the school kids. However it seems that now there is more interest. Sooke does not have CB radios.

Action Item: A group needs to be formed to develop a protocol for radio communications during an event, between Sooke and Juan de Fuca EA EOCs.

What would you like to see at the next ShakeOut BC?

1) Sooke Marine SAR would like to participate next time, and they want to become involved in the JdF Emergency Program again.

2) Table Top Exercise – to exercise EOC and one of the communities on the West side.

- 3) HAM radio course the question was asked if this is still going to happen. B. Webb stated that there seems to be a lack of enthusiasm for this course.
- 4) Rec Centre and Fire Hall issues in Port Renfrew need to be resolved. However if this does not happen then the Port Renfrew Elementary School will be used.
- 5) Malahat T. Dixon stated that he needs someone to help him out and the communication is very important.
- 6) Shirley D. Bernadet was not in Shirley at the time of exercise.

7) Otter Point – Communications is a very big issue.

- 8) Jordan River There are no buildings in Jordan River that can be used as a gathering place and they will rely on the Shirley Community Hall. There are several HAM radio operators in the area.
- E. VI Emergency Preparedness Conference 15 17 April 2011. R. McLeod and B. Broster reported that they had a walk-thru of the hotel conference space and kitchen last week. Online registration is now open. There are approximately 300 to 350 registrants currently. A poster presentation will be on Friday evening; currently there are three or four poster presentations registered. There will be six delegates from the Sooke Fire Department going. There will be three people from Sooke shadowing the Langford ESS to learn group lodging. All is coming together really well. There will be advertising.
- F. Juan de Fuca Emergency Website meeting on 11 January 2011: The new web site <a href="www.jdfem.com">www.jdfem.com</a> was launched and has been met with great success. If you Google the site, it is the first site identified, thus is being viewed world-wide and is a top viewed site. Steve Holland has done an excellent job on the site and it is still evolving. If you wish something to appear, please let Steve Holland or G. OBriain know. It was suggested that the website be made mobile friendly; also that perhaps it is too busy for just one page and should be divided into two pages.

#### New Business:

B. Emergency Coordinator: A reminder to pick up your supplies from G. OBriain and all the CC's to pick up their vehicle signs. The signs are to displayed only when there is training, an emergency, or travelling about in the business of the JdF Emergency Management Program. The organization for the CRD Emergency Management Committee has gone before the Board. It is made up of the CRD CAO, GM, EA Directors and T. Whiting. They will meet a minimum of once annually and will be reviewing all plans. All EAs will be going on a 5 year strategic business plan for all EA EP's. It has to be measureable and achievable. Regarding Steve Holland's presentation at the VI Emergency Conference, she does not think that this is going to happen, however she said to check with Steve Holland.

They were turned down for a grant. They received a Community Grant from Sooke for \$15,000 to outfit 15 volunteers with new gear complete with suits and helmets.
