#### 8. Committee Reports:

## a) Dinner Bay -

- The park looked great for Lions Salmon BBQ, before and after. Thanks to Moe MacLeod for mowing. The green mower has returned (finally!) and works just fine. Some winterizing work to do on the putting green.
- Mark Aitken has done some tree trimming.
- More soil to come for the ball field, and leveling.
- Small bridge and pump box to be built near the ball field.
- The bench presently on the Lions trailer is to be moved to Miners Bay.

## b) Village Bay -

- Discussions ongoing with AMIB & CRD re the fuel/propane barge landings and loadings. How
  much should they pay and to whom. Doug will enquire about the actual cost of a fuel truck on the
  DG ferry. AMIB wants Doug to join their board.
- Some trees need fall trimming.
- Watering of the Gary Oaks has been valuable.
- Cement staircase project is nearing a start date.

## c) Japanese Garden

• 95% of pathways were weeded and then covered with roadbase. Teams of volunteers and Lions did the work.

#### d) Emma & Felix Jack Park -

Park is looking great – always thanks to Don De Rousie.

## e) Henderson Park and Trail Network Development --

• Peter did a walk-about with Zack and his assistant on their next project; used the Mittens' driveway (with permission) to access the job site. This route will make their job easier and more efficient.

- On the TND 'wish list':
- a staircase at Neil Road to replace the present rope arrangement. Some problems here with building on a SRW.
- in Plumper Park, hopes for a staircase in the very steep SW corner; would replace, or at least improve, the present switchbacks.
- a boardwalk, approx. 30" wide & 30' long not straight to be placed on a muddy stretch of Punch's Alley.
- Amy volunteered to take on guardianship of Naylor Road beach access.
- Most signage finally arrived. Thanks to BC Ferries for sheltering them. Some already in place at Henderson.
- Two truck loads of surplus cedar fence moved from Miners Bay to Henderson. Thanks to Andre Guy and Peter Hansche.

## f) Miners Bay

- Will be the site of the Terry Fox Run, Sept. 18. MIPRC will provide delicious dessert to accompany the burgers or hot dogs cooked by the Lions. The Terry Fox flag will fly at the Park until Oct. 1/11.
- Rien Van Veld continues his work on the new flower bed walls. To come next, drain rock & top soil, then planting. Mulch for the slope garden arriving in about a week. Supplies for the new front path to the road are ordered. Date and crew to move bench from Dinner Bay to Library patio being arranged.
