2. Approval of Agenda:

6. MBAC Advice & Guidance

MOVED by B. von Sacken, SECONDED by T. Fenwick

That the committee endorse the report: Mountain Bike Guidelines: Advice & Guidance, and recommend it be forwarded to CRD Regional Parks staff.

6.1 Editorial Changes

D. Leong and T. Fenwick provided grammatical edits to Chair Ellis. The committee agreed that Chair Ellis should proceed with implementing those changes and that the committee did not need to review them as there were no substantive changes to the text.

6.2 Items for Discussion

- D. Cammiade sent an email to Chair Ellis with proposed edits he had discussed with and agreed upon with H. Rose, A. Soraya, and H. Prince:
 - p. 21 Map There was discussion about the asterisks and whether the map added value, needed a key, etc. It was decided to remove the asterisks to not reference the bike parks.

ACTION: B. Wyman to lead the edits to the map.

- A. Soraya asked that the "What is Mountain Biking" section include reference to mountain-bike-rated trails to help readers understand the map. Chair Ellis to ensure the content supports the map.
- p. 23 It was decided to remove "in recent years"
- p. 28 It was suggested that the heading for Table 2 replace "example" with "recommended." Discussion ensued and the committee agreed to retain the current wording.
- p. 30 It was decided to add "Improved environmental integrity" to the list of benefits of a consistent service delivery model.

Andrew Pape-Salmon, alternate committee member for D.Cammiade, submitted suggestions via D. Cammiade.

- p.16 It was agreed that NGO capacity should be added to "trail development capacity"
- p.20 It was suggested to define what green, blue, black, and double black meant for the layperson. The committee agreed to include a new appendix describing the characteristics of each difficulty rating.
