- 5. Election of officers. All acclaimed as follows:

### 6. Finance

The treasurer had no new figures to report since the last meeting. He expects the CRD to complete the year end statements by late February or early March, but the year's operating surplus should be known by our **February meeting**, and we will need to make a decision about how to allocate it then.

## 7. Chief's Report

a. Callouts since last report: 1 Medical, 1 chimney fire that morphed into a small structure fire but was easily extinguished. b. The department has an invoice for \$500 for its share of funding for fire safety information at ferry terminals during the summer as part of the Community Wildfire Protection Plan (CWPP). The invoice

was referred to the Society to pay as part of its public education function.

c. The Gulf Islands Mutual Aid Agreement has been finalized.

d. In response to the Chief's report on water sources for fire suppression Sandy Moodie reported a large potential water source that could be used to service Cameron Lane and adjacent areas more quickly than Laughlin Lake.

# FD Officer Roger Allen and Chief Darby to investigate

e. Crest Radio upgrades will be operational by the Spring of 2018. Expenses for new pagers and some radios will need to be covered in the **2017 budget**.

f. Outfitting of the new Emergency Response Vehicle is close to complete. The delivery date will be known shortly.

g. 2 modules of the Playbook have been completed and the firefighters taking the training evaluated. First responder training for recertified and new FRs is about ¾ complete. Remaining: The new requirements include a substantial amount of training in legislation and legal issues possibly governing FR practice. h. Website—the Department's website is seriously out of date and not maintained. Request to join the department and burn permit queries go unanswered.

M/S that we contact a qualified person to redesign the Fire Department website to make it more accessible and useable with a view to keeping it current in the future.

Roger Pettit to seek appropriate personnel and provide cost estimate for redesign and ongoing maintenance.

### OTHER BUSINESS

The Commission has been informed that Emergency Services, which provides support (e.g., food and hydration) to firefighters at incidents, will now be required to bill the department for these services. Roger will raise this issue at the next meeting of the Emergency Services Commission. **Attention: Roger**
