

REPORT TO SAANICH PENINSULA WASTEWATER COMMISSION MEETING OF FRIDAY 18 JUNE 2010

SUBJECT

HAULING CLASS "A" BIOSOLIDS, LIME STABILIZED BIOSOLIDS AND DEWATERED SLUDGE FROM THE SAANICH PENINSULA WASTEWATER TREATMENT PLANT – AWARD OF CONTRACT 2010-433

PURPOSE

To seek approval for award of contract for the hauling of biosolids and dewatered sludge from the Saanich Peninsula wastewater treatment plant.

BACKGROUND

The Capital Regional District (CRD) operates the Saanich Peninsula wastewater treatment plant which produces Class "A" lime-stabilized biosolids and unstabilized dewatered sludge under various operating conditions. The biosolids and sludge are currently hauled to the Hartland Landfill for distribution or disposal.

The following tenders were received on 21 May 2010, for Contract 2010-433 – Hauling Class "A" Biosolids, Lime Stabilized Biosolids and Dewatered Sludge from the Saanich Peninsula Wastewaster Treatment Plant – for a period of two years commencing 01 August 2010:

Ellice Recycle Ltd.	\$124,005.00
Boon's Bin Boy Services Inc.	\$154,386.40

The tenders have been reviewed for content and accuracy. The low tender from Super Save Disposal Inc. complies with the instructions to tenderers and is in accordance with the annual operating budget for this work.

ALTERNATIVES

- That the Saanich Peninsula Wastewater Commission recommend that Contract 2010-433 Hauling Class "A" Biosolids, Lime Stabilized Biosolids and Dewatered Sludge from the Saanich Peninsula Wastewaster Treatment Plant, be awarded to Super Save Disposal Inc. in the amount of \$38,227.35.
- 2. That the Saanich Peninsula Wastewater Commission not approve the award of contract, and identify an alternate means to haul biosolids and dewatered sludge.

FINANCIAL IMPLICATIONS

The contract will be funded from the Saanich Peninsula wastewater annual operating budgets.

SUMMARY

The Saanich Peninsula wastewater treatment plant produces Class "A", lime-stabilized biosolids and unstabilized dewatered sludge which must be hauled from the site to the Hartland Landfill. The low bid of \$38,227.35 for the two-year hauling contract has been received from Super Save Disposal Inc.

RECOMMENDATION

1. That the Saanich Peninsula Wastewater Commission recommend that Contract 2010-433 – Hauling Class "A" Biosolids, Lime Stabilized Biosolids and Dewatered Sludge from the Saanich Peninsula Wastewaster Treatment Plant, be awarded to Super Save Disposal Inc. in the amount of \$38,227.35.
