#### **Our Shared Cultural Ecosystem**

Both Salt Spring Arts (SSA) and ArtSpring Community Arts Centre are key organizations that contribute to the arts, culture, and community ecosystem on Salt Spring Island. Our creative ecosystem is composed of many parts - creative individuals and groups, curious audiences, a variety of cultural facilities and resources, and the intricate relationships between all of the parts of the whole.

By its very nature, Bylaw No. 3116 "Salt Spring Island Arts Contribution Services Establishment Bylaw No 1, 2003" recognizes the significant role these two organizations have in supporting Salt Spring's rich cultural ecosystem.

As flagship organizations, SSA and ArtSpring help to nurture local creativity and connection, an essential part of our vibrant and engaged community. They each have distinct but complementary roles in enriching the cultural landscape of the island, promoting artistic expression, and fostering community engagement. Here's how they serve the arts, culture, and community ecosystem:

#### **Salt Spring Arts' Unique Contributions**

Salt Spring Arts (SSA), community arts council:

- Supporting Artists and Inspiring Creativity: Our programs and activities contribute to the cultural fabric, quality of life and sense of belonging on Island. As a cultural convener, we are about to launch a free calendar to better connect audiences to local cultural events.
- Accessible Programs: Our commitment to accessible arts means that nearly all our programs are free to our community. Artist in the Class, murals in Ganges, concerts in the park, and Art Jam are just some of the ways in which we ensure the arts enrich the lives of a wide range of our community members.
- **Diversity of Arts**: SSA emphasizes celebrating and promoting a variety of art forms, recognizing that a diverse range of artistic expressions is vital for a healthy community.

- This approach encourages artists from all backgrounds, experiences and disciplines to showcase their work or deepen their skills.
- Strengthening Local Capacity for Arts & Culture: SSA provides support and resources to both individuals and cultural organizations on island. We create opportunities for local artists to earn an income from their work, distribute project grants to groups, and manage Mahon Hall as a community cultural centre. We collaborate across-sectors and advocate for the role of the arts in our community.

#### **ArtSpring's Unique Contributions**

ArtSpring Community Arts Centre:

- Facility and Infrastructure: ArtSpring operates a dedicated arts centre with facilities for a variety of activities, including a theatre, gallery, and workshop space. This infrastructure allows artists and performers to showcase their work and the community to participate in cultural events.
- Promotion of Creativity: ArtSpring's mission focuses on promoting artistic creativity.
   Through exhibitions, performances, and other events, it fosters a culture of creativity and innovation.
- **Public Education and Outreach**: ArtSpring actively engages in public education, supporting not only the arts but also community growth and health. This aligns with its goal to bring high-quality performances and art from various sources to the island, enriching the cultural experience for residents and visitors alike.
- **Global Connections**: ArtSpring's mission includes bringing in talent from British Columbia, Canada, and internationally. This creates opportunities for cultural exchange and exposes the community to a broader range of artistic expressions.

#### **Complementary Roles Strengthening the Arts on Island**

Together, SSA and ArtSpring nourish a comprehensive ecosystem for arts and culture on Salt Spring Island. SSA's focus on accessible cultural opportunities, strengthening local capacity, and artistic diversity complements ArtSpring's emphasis on infrastructure, public education, and global connections. Both organizations contribute to a thriving arts community, providing much needed spaces for creating and sharing creative expression, supporting local artists while bringing in outside talent to enrich the cultural landscape.

#### **Current Challenges in the Arts**

In summary, these two organizations work in tandem to ensure that the arts are not only present but also a vibrant and integral part of the Salt Spring Island community. They create a space where creativity thrives, education is valued, and the community can come together to celebrate the arts. The past few years have brought an increasing level of complexity and

challenges to operations in the arts. Challenges that became more enhanced in a Post-Covid environment include:

- Sustainable funding and financial sustainability is at risk
- Audience engagement and attendance is slow to rebuild
- The impact of digital entertainment
- Staff retention and burnout leading to mental health challenges
- Operational and program delivery costs rising well beyond inflation
- Maintaining community ties and impact is requiring greater investment and capacity

In summary, Salt Spring Arts and ArtSpring in a post-COVID world must navigate a complex landscape of financial challenges, audience engagement, operational adaptability, and community connection. Addressing these issues requires creativity, adaptability, and strong community relationships.

#### Now is the Time to Invest in Local Arts

- Our Request: 25% increase in 2025, with a commitment 5% increase for the next 3 years
   to support planning and a level of stability
- In the volatile arts climate, CRD can help stabilize and strengthen both of our organizations
- The Arts Requisition is a key opportunity to make an investment in our Island's cultural ecosystem
- This is a crucial time in our local community, where we are seeing arts groups, artists and the demand for the arts bounce back in new ways, post-COVID
- This investment will benefit the whole Salt Spring community through creating a healthy, supportive and purposeful environment while contributing to the local economy through a strengthened program delivery and infrastructure development.

Subject: Request for a 25% Increase in Funding from the Capital Regional District for ArtSpring Community Arts Centre

Dear Karla Campbell, Capital Regional District

Thank you for the opportunity present our case for increased funding from the Capital Regional District through the Tax Levy fund. We are seeking a 25% increase to primarily support our ageing infrastructure and to build capacity to support our programs and build on the impact from our 25<sup>th</sup> Anniversary Season.

#### Assessment of the Past Year:

The 2023/2024 season, our 25<sup>th</sup>, has been a success on many levels. The audiences are beginning to return and are seeing new and returning members of our community. Having finalized our Strategic Plan in early 2023, we have begun several initiatives to improve organizational performance and connection to community. As I describe below, our recent 25<sup>th</sup> Anniversary celebration festival was a tremendous success that was embraced by over 2,000 visitors and participants.

We initiated new accessibility ticketing pricing programs that addressed some economic instability in our community and opened our doors wider for audience members and performers. We developed new partnerships with local performing arts groups, like Bach on the Rock and Stagecoach Theatre and promoted local talent, like Salome Cullen, a recent High School student who opened for Blue Rodeo's Jim Cuddy.

Thanks to a generous bequest, we have started a new Legacy Endowment Fund of \$500,000 that was recently matched by the Federal Government awarding ArtSpring \$285,000

The challenges continue to persist:

- Sustainable funding and financial sustainability
- Audience engagement and attendance
- Impact of digital entertainment
- Staff retention and burnout
- Operational and program costs (beyond inflation)
- Investment required to retain community impact

#### Case for Support

ArtSpring Community Arts Centre has been a cornerstone of artistic and cultural expression on Salt Spring Island for the past 25 years. Our mission to serve the community through arts education, cultural presentations, and support for local artists has never been more relevant. However, our ageing facility requires significant maintenance and updates to ensure we continue providing high-quality programs and experiences for our community.

ArtSpring is a hub for creativity and cultural connection. We offer a diverse range of performances, exhibitions, and workshops, drawing audiences from across the Gulf Islands and beyond. Through our work, we promote creativity, cultural understanding, and economic development. Our commitment to sustainability further underscores our role in the community's long-term health and well-being. The requested funds will support our facility's ongoing operational needs, enable necessary maintenance and repairs, and ensure that ArtSpring remains accessible and affordable to all members of the community. This will allow us to continue attracting high-quality artists and performances while providing a platform for local talent to grow and thrive.

#### **Impact**

ArtSpring has made a significant impact on the Salt Spring Island community. We have hosted diverse local, regional, national, and international artists, bringing unique cultural experiences to our audience. Our facility's strategic location between Vancouver and Victoria, along with proximity to Vancouver Island, has allowed us to attract talent that might otherwise bypass smaller venues.

In addition to providing a space for artistic expression, we have invested in technical production and theatre infrastructure, allowing artists to perform in a state-of-the-art environment. Our ongoing commitment to community engagement is reflected in our collaborations with local schools, youth programs, and other community organizations.

The 2023/2024 season, marking our 25th anniversary, features an impressive lineup of performances, including a world premiere from the Gryphon Trio, a performance by the Isidore Quartet from NYC, and presentations by emerging artists like the Fugitives and Meghan Gardiner. These events draw visitors and generate revenue for local businesses, contributing to the economic vitality of the region.

ArtSpring is also deeply committed to truth and reconciliation. Our week-long festival, Matriarch's Uprising, featured Indigenous choreographers and Inuit throat singers, demonstrating our dedication to fostering a culture of inclusion and reconciliation.

#### **Our 25th Anniversary Celebration**

In April, we held a week-long celebration to mark our 25th anniversary. This special event attracted over 2,000 residents and visitors, showcasing the vibrancy of Salt Spring Island's artistic community. The celebration was a resounding success, featuring a program with over 90% local artists and a range of activities designed to engage the entire community.

The primary achieved objectives were:

- a. Establish ArtSpring as champion of the Community
- b. Be a place that welcomes all
- c. Celebrate the builders and the early Visionaries
- d. Explore future possibilities
- e. Begin to build community centred Case for Support
- f. Enlist the community in the shape and execution of our Celebration

Highlights of the celebration included:

- **Community Dance**: Salt Spring's Everyday People led a joyous community dance, bringing together people of all ages to celebrate through music and movement.
- **Family Activities**: We organized a variety of free family-friendly activities, ensuring that everyone, regardless of age or income, could participate in the festivities.

- **Affordable Events**: In addition to free performances, we offered low-priced tickets to a series of events featuring world-class artists with strong connections to ArtSpring's mission and history.
- **Benefit Performances**: The Jim Cuddy Band headlined two sold-out benefit performances, helping raise funds to support ArtSpring's ongoing operations.

The anniversary celebration exemplified ArtSpring's commitment to inclusivity, community engagement, and support for local talent. By providing a platform for local artists to perform alongside internationally renowned acts, we created a unique and memorable experience for our audience.

#### **Request for Increased Funding**

To continue providing high-quality arts programming and support the ongoing operation of ArtSpring, we respectfully request an increase in funding from the CRD, totaling \$125,000 for the upcoming fiscal year.

The additional funding will be used to address the following critical areas:

- Facility Maintenance and Operations: Our 25-year-old facility requires significant maintenance and
  upgrades. According to the 2021 Building Assessment report, over \$1M is needed for lifecycle issues
  over the next 20 years. In 2024, we need to replace aging carpets and rebuild the pedestrian bridge.
  Regular maintenance of HVAC systems, the elevator, and lighting is also essential to ensure safety
  and accessibility.
- Capacity Building: To maintain our professional staff and attract top talent, we need to offer
  competitive wages and a positive work environment. The additional funding will support staff
  retention, professional development, and expanded capacity to deliver high-quality programs and
  services.
- **Sustainability Initiatives**: ArtSpring is dedicated to environmental sustainability. The increased funding will allow us to invest in eco-friendly technologies, demonstrating our commitment to a greener future and inspiring others in our community to do the same.

#### Conclusion

ArtSpring Community Arts Centre is a vital asset to Salt Spring Island, promoting creativity, supporting local artists, and enriching the community through diverse arts programming. As our community evolves, we must ensure that our facility and programs meet the changing needs of our audience.

We are seeking the support of the CRD to continue our mission of enriching lives through the arts. An increase in funding of 25%, will provide some of the necessary resources to contribute to maintaining our facility, expand our programs, and engage a broader and more diverse audience. We are grateful for your consideration and look forward to discussing further how ArtSpring can continue to serve as a valuable asset to our community

- Meetings held once a month for three months, open to all and advertised in both the Driftwood and the Exchange.
- Reports of these meetings were published in the Discussion and Opinions section of the Exchange to generate comments as well as encourage attendance at the monthly meetings.
- Additionally, an email was established and well-publicized, seeking feedback from those who may not attend the meetings nor add comments to the Exchange postings.

While the monthly meetings were not as well-attended as hoped, nor did the Discussion and Opinions section of the Exchange generate an enormous amount of feedback, the email did, in fact, result in a great number of comments and, by the repetition of certain issues, their prioritization.

#### The Resulting Prioritization of Road Safety Concerns

- 1) **Funding:** More funding should be allocated to street sweeping and painting. This funding should be enough to fund Emcon to sweep our roads more frequently and for Lafrentz, the painting contractor, to paint all of our roads (both centre and fog lines) every year as well as adding and refreshing lines at all stop signs.
- 2) **Flexible Reflectors:** As the water-based paint used lasts only a short period and some of our narrow, most dangerous roads do not qualify for line painting, it is recommended that long-lasting, relatively-inexpensive flexible reflectors be gradually added to all our curves.

It is suggested that 50 Flexible Reflectors be added every year for a least five years, at an approximate cost of \$3,500 year, (not including installation).

- 3) **Crosswalks:** The Ganges Active Transportation Network Plan, written in consultation with MoTI, recommended a study analyzing Ganges crosswalks. ICBC has offered to do this study as well as funding recommended improvements. All that is needed to proceed is a letter to MoTI requesting approval of this study. Please approve a letter to MoTI requesting support of this study.
- 4) **Speed Limits:** Despite joy at reducing Ganges speed limits to 30 km/hr, there were many comments suggesting additional areas needing a speed limit reduction. While this group was not confident suggesting specific locations for reductions, it asks that the MoTI analyze Salt Spring speed limits, especially addressing the speed reduction recommendations of its Salt Spring Islands Cycling Safety Plan ( <a href="https://www2.gov.bc.ca/assets/gov/driving-and-transportation/reports-and-reference/reports-and-studies/vancouver-island-south-coast/2023-04-21\_salt\_spring\_island\_cycling\_safety\_review.pdf">https://www.pdf</a> ).
