Chair Martin called the meeting to order at 4:01 pm.

1. Election of Vice Chair

Chair called for nominations for Vice Chair. Director McIntyre nominated Commissioner Cunningham, seconded by Commissioner Grimes. Chair called three times for further nominations, and hearing none, closed nominations and Commissioner Cunningham was elected by acclimation.

2. Approval of Agenda

MOVED by Director McIntyre, **SECONDED** by Commissioner Quiring, That the agenda be approved.

3. Adoption of Minutes of February 5, 2015

MOVED by Director McIntyre, **SECONDED** by Commissior Quiring, That the Minutes of February 5, 2015 be adopted with the amendment under item 5.1, second bullet, replaced "nominated" with "elected".

4. Presentations/Delegations

Salt Spring in the City – Deanna Milligan

Members of Salt Spring in the City group attended and presented a report on 2nd annual event taking place March 27-29, 2015 at Heritage Hall in Vancouver. Marketing in place for 2015 includes a graphic postcard to hand out to the public, in kind sponsorships from: GlobalTV for tv ads worth \$20,000; Georgia Strait print ads worth \$7,000; Salt Spring Coffee Co. providing coffee and 75 gift bags; Peak Radio contest (airfare to Salt Spring, B&B stay, dinner, scooter rental, kayak trip, BC Ferries tickets). Thirty-six vendors in total, with estimated attendance at 3,000 plus. General discussion with Commission. 2014 event brought awareness of Salt Spring as a destination and also the Saturday Market. 2015 event budget needs met; seed money required to ensure 2016 event possible.

5. Reports

5.1. Director

Attended Drake Road steering committee meeting with CRD Headquarters to

acquire up to 80 housing units, targeting for Local Trust Committee meeting in April – divided between rental and purchase – done in stages to offer more on-island resources to be involved.

- Attended Environmental Services Committee meeting to acquire recycling for four years approved by Environmental Services Board to go to CRD Board to request four years of bridge financing to lower overall taxpayer contribution.
- Met with Aqualini Group, owners of sablefish farm, to organize meeting of manager of facility and neighbours to improve relationship and discuss noise issues.
- Pathway at the Harbours End is on schedule and may come in under budget.
- Peck's Cove vision by Robin Williams to have commissions work together (Transportation, CEDC and PARC).

5.2. Chair

- Met with John Wellingham who has volunteered to assist with Shell Station already interacting with ownership group.
- Emails with Shell and Esso who have abandoned stations on Salt Spring.
- Met with Green Sector representatives wanting to try to tie in more closely Transitions Coop
- Received and returned a number of phone calls about Treehouse issue not resolved but look forward to more concrete results at next meeting.
- Attended CRD Orientation for new commission members main things: notion that whenever a quorum is gathered, it is an official meeting; recognize that FOI applies to all Commissions correspondence etc. can be brought forward for inspection.
- Met Community Economic Development group of Duncan open to using some of their business development counselling for Salt Spring Island.
- Made initial contact with Catalyst Paper in Crofton an employer of many Salt Spring residents.
- Attended public meeting on Age Friendly Pilot Study.
- Attended Green Drinks event.
- Made a presentation at a breakfast event speed-style a dozen different groups with four minutes to give accounting.
- Reviewed changes to Strategic Plan.

5.3. Commissioner Grimes

Healthy Harbours project – derelect vessels and debris on ocean floor feasibility study needed; storm water run-off carries pollutants into harbour can be addressed through education, rain gardens and how they can contribute to clean run-off. Demonstration rain garden possible.

5.4. Commissioner Cunningham

Attended invasive wildlife seminar in Saanich Peninsula – water contamination issue with geese, damage to crops from geese, deer and rabbits; a lot of green space suffering economic damage and health and safety from geese; sent information to Wayne for guidance. In Saanich Peninsula CRD is in charge; Salt Spring Island has no mandate.

5.5. Li Read – Chamber President

- Chamber bylaws currently state only Chamber members able to attend Chamber Board meetings. Bylaws need to be amended to allow non-Chamber members at Chamber Board meeting.
- Chamber doesn't receive funding except for in kind from Tourism Vancouver Island.
 At meeting held in Tofino it came up that visitors noted there is a lack of accommodations which needs to be addressed. addressed.
- Create a new tourism map to include Georgia Strait, Galiano, Salt Spring, Cowichan and west call it a "Fat Map".

6. Outstanding Business

6.1. 2015 Action Plan and 2014 Economic Development Repor Additions to Report provided and discussed.

MOVED by Commissioner Quiring, **SECONDED** by Commissioner Cunningham, That the Salt Spring Island Community Economic Development Commission ratify the 2015 Action Plan and 2014 Economic Development Report with additions as presented.

6.2. Beautification Project – John Wellingham

Mr. Wellingham made a verbal report on his efforts to date with the beautification of 106 Lower Ganges Road: discussions with present owners; internet research of products available to attach to fence, owner may consider permitting weatherproof artwork on the fence.

MOVED by Commissioner Quiring, SECONDED by Commissioner Grimes,

That the Salt Spring Island Community Economic Development Commission allocate up to \$5,000 for the beautification of the former Ganges Shell Station (106 Lower Ganges Rd), in accordance with the law, to: install low profile traffic barriers to create a safe pedestrian route; clear away weeds and align fence and arrange for the supply and installation of weatherproof artwork on the fence.
