2. Adoption of Minutes of February 16, 2017

3.1 Michael Ableman-SSI Saturday Farmers Market

Mr. Ableman presented his opinions on the layout of Centennial Park relating to the Saturday Market in the Park.

- No shortage of space
- Rethink and make more functional
- Create a Farmers/Food Area by closing road
- Spread out remaining vendors to allow space for people to walk and view items
- Better access for farmers to set up in road area
- Farmers have special needs; items are perishable and require space to display
- Urgent need to support local growers
- Recommends having a Farmers Market Consultant from outside the area review issues and come up with a long term plan

Director McIntyre joins the meeting at 4:25 pm

- CEDC could offer support to farmers for equipment, infrastructure and technology
- Moderate climate could support off season growing
- 4. Director, Chair and Commissioner Reports
 - 4.1 Director McIntyre briefly reported on the following:
 - Drake Road affordable housing project- Islands Trust has made a formal motion of support for the project- CRD moving forward with Hydrology Study to seek alternative water source.
 - CRD Governance Committee is seeking enhanced web streaming of meetings to increase quality, access and transparency.
 - CRD has endorsed the use of the CREST Radio Services for five years.
 - Terms of reference established for new housing and hospital committee which links health, housing and funding for projects.
 - Harbour Walk Project Steering Committee has been selected and includes a member of the Harbour Authority; now seeking a project manager.
 - Facilitated communications between Harbour Authority and BC Ferries regarding the Fulford terminal upgrades 2019.
 - Incorporation Vote set for September 9, 2017; public debates will be held and conducted with a moderator.
 - Second phase of CRD passenger ferry study-feasibility of boat connection by loop routes between Ganges-Sturdies Bay-Miners Bay and Sydney- Ganges.
 - **4.2** Chair Martin briefly reported on the following:
 - Attended meeting with Southern Gulf Island Economic Development Commission; considering an independent body to do economic development for them; creating a website to attract permanent residents.
 - Attended meeting for Regional Trails on Salt Spring
 - SSNAP 2017 has provided details on recognition of funding by CEDC.
 - **4.3** Commissioner Carlin referred to a written report on the Rural Business Accelerator and began the discussion on the Small Business BC Webinar Partner Program.
 - Online educational resources for business start-up and on-going success
 - Revenue sharing structure
 - 30% discount on all Webinars for CEDC members;
 - 30% revenue sharing on every Webinar Booking through CEDC;


