6.1 Rural Islands Economic Partnership Rural Dividend Application

Whereas, the Salt Spring Island Community Economic Commission and the Southern Gulf Islands Community Resource Centre along with the 16 Rural Islands Steering committee of the Rural Island Economic Forum, are as an adjunct to the Forum, preparing a funding application to the BC Rural Dividend Fund for a grant to establish the framework for a permanent organization. A permanent economic organization for the Southern and Northern Gulf Islands and Howe Sound, will facilitate collaboration, address common challenges and seek solutions to foster a resilient economic future. Through this economic partnership, BC's rural islands will access coordinated resources, education, and infrastructure for achieving community economic well-being in the face of climate change.

Therefore be it resolved that the Salt Spring Island Community Economic Commission supports entering into a fee for service contract in the amount of \$6,000 with the Southern Gulf Islands Community Resource Centre as the Rural Dividend Project Holder to create a platform for a permanent organization for collaboration, communication and advocacy to achieve and sustain community economic resilience on behalf of BC's rural island.

6.2 Southern Gulf Islands Tourism Partnership Society

Whereas, the Southern Gulf Islands Tourism Partnership Society (SGITP) is leading in new efforts to engage island businesses, visitor experience providers, and transportation suppliers to extend the tourism economy throughout the year by collaborating with regional and local partners. The Salt Spring Island Community Economic Commission (CEDC), along with SGITP envision that these efforts will result in programs that offer year-round employment for families that live and work on Salt Spring. The importance to the sustainability of our islands regional tourism economy, and for those dependent on the health of the economy, is having increased access to marine transportation connections in the Southern Gulf Islands region. It is a key component for insuring year-round visitation and a year-round economy for our Islands. The CEDC is supportive of initiatives that will expand the use of clean energy ground transportation networks, and the linking of these networks with low-emission marine based transportation via the 'Ahoy BC 'marine trails.

Therefore be it resolved that the Salt Spring Island Community Economic Commission supports entering into a fee for service contract in the amount of \$5,000 with the Southern Gulf Islands for the development of a plan and program for initiatives that will expand the use throughout the Southern Gulf Island region use of clean energy ground transportation networks, and the linking of these networks with low-emission marine based transportation via the 'Ahoy BC 'marine trails.
