1. Call to Order

Director Hendren called the meeting to order at 1:30 p.m.

5. Annual Report

Staff presented a written report. The following topics were addressed:

Staff advised as clarification to the annual report that the value referred to "2.1 million - a budget increase of at least one million". The total anticipated value is 3.35 million excluding composting.

It was agreed that discussions regarding off-island hauling would be deferred to the budget meeting directly following the Annual General Meeting.

The commission received the annual report for information.

6. Election of Officers

Director Hendren advised that the term for Dave Howell will expire on December 31, 2011. Dave Howell noted that he did not wish to run for an additional term. He then called for nominations. Maxine Leichter was nominated and agreed to stand. Nominations were called for two more times, and hearing none, Maxine Leichter was elected by acclamation for a two-year term beginning January 1, 2012 and expiring on December 31, 2013.

John Sprague was appointed by the Ganges Sewer Local Service Commission as a representative for Ganges Sewer on the Salt Spring Island Liquid Waste Disposal Local Service Commission for an additional two-year term expiring on December 31, 2013.

Their names will be forwarded to the CRD Board for appointment.

The representative for Maliview Sewer from the Highland Water and Sewer Local Service Commission be appointed by the Highland Water and Sewer Local Services Commission at their next meeting.
