- **4.1 Director Holman** briefly reported on:
 - CRD Board approved final budget for 2019
 - SSI overall 1.8% increase

 Improvements to pedestrian and cyclist safety in downtown core 3) keep the NGTP

- 4.3 Commissioner Johnston advised that she is participating in the organization of a petition to the MLA for action on safety issues; requesting an expanded "village area" with lower speed zone and creation of posted "senior" zones similar to school zones.

5.1 BC Transit – Development Referral Response - 132 Corbett Rd.

Manager Campbell reported that the first portion of the archeological study is complete and will guide the next application which needs to be applied for to do any works in the area. There is potential that some redesign work will need to take place.

Subject: Installation of full transit driver doors

Dear Local Government Partner,

We would like to inform you of BC Transit's recent decision to move forward with an important safety initiative that will see the installation of full driver doors on all high capacity, heavy duty, medium duty, commuter and coach buses in our fleet. This will involve a program to retrofit approximately 650 buses in our current fleet by 2022, as well as the delivery of new buses with full driver doors installed.

We are currently preparing an RFP (Request for Proposal) to find a vendor to supply and potentially install full driver doors on our buses. Based on data collected from a pilot program in several communities, along with previous trials and industry knowledge, we have now finalized our design specifications. The full driver door will include a transparent piece of plexiglass-type material with a metal base. It will also include a window which can be adjusted to account for sightlines associated with different seating positions. The window will also allow the driver to interact with customers in a positive and friendly manner. Overall, the design will improve comfort and increase protection for the driver, while also limiting distractions.

Safety is BC Transit's top priority and the introduction of the full driver door is one of many initiatives introduced to further enhance the effectiveness of our safety program. They include closed circuit television cameras (CCTV), driver training to diffuse situations, and partnerships with first responders in communities around the province.




GradPASS is a valuable program that promotes public transit as a lifestyle choice,

GradPASS aims to help students consider all transportation options when planning a safe ride home at graduation time, and throughout their lives.

Once your school has enrolled in the program, GradPASSes will be distributed to you annually in May. After receiving the passes, please distribute them to your grade 12 students.



To use the passes, students must scratch off the appropriate date on the pass before boarding the bus. When using the passes, drivers may ask to see their student ID to confirm their eligibility to use the pass.
