BC Recycling Regulation



Products currently captured in the Recycling Regulation for Extended Producer Responsibility in BC:

- Refundable Beverage Containers
- Electronics, Electrical Products, Batteries and Lighting
- Lead-acid Batteries
- Paints, Solvents, Flammable Liquids, Gasoline, Pesticides
- Pharmaceuticals
- Packaging and Printed Paper
- Tires
- Used Oil, Filters, Containers



Producer Responsibility Organizations



PROs - Industry-led recycling programs in BC:































Recycle BC



- Recycle BC is the PRO formed to meet producers requirements in relation to Schedule 5 of the Recycling Regulation
- Responsible for packaging and printed paper supplied to BC residents, including:
 - Printed paper and cardboard
 - Glass bottles and jars
 - Paper, plastic, and metal containers
 - Non-deposit glass bottles and jars
 - Flexible plastic packaging

COLLECTION STREAMS



CURBSIDE COLLECTION

Collection from households that set out materials individually for pick-up



MULTI-FAMILY COLLECTION

Collection from a central location in residences with five or more units



DEPOT COLLECTION

Residents drop off their materials



Key Concerns in CRD Letter



- 1. Establish appropriately ambitious performance targets
- 2. Invest in enhanced service levels in all areas, particularly for residents in multi-family buildings
- 3. Provide funding for collection from single-family residents that aligns with actual costs
- 4. Address barriers in siting of depots and grandfather existing sites
- 5. Provide access to packaging and printed paper processing and marketing for communities not meeting proposed criteria
- 6. Enhance system for collection of non-curbside material
- 7. Enhance streetscape programming
