b) Staff News

Jumpstart Enabling Access Grant

A \$14,500 grant application has been submitted to Jumpstart to help remove facility physical accessibility barriers identified in the 2017 Leisure Access Victoria App.(LAVA) report. These items include; automatic door openers, automatic sinks and automatic toilets. SEAPARC has capital funding in place to match Jumpstart grant funding for a total project value of \$29,500. Should the grant be successful, the project is scheduled to be completed during the 2019 pool shutdown.

Fees and charges

SEAPARC's annual fees and charges review is currently underway. Further to this review, an audit of regional golf course fees was conducted in February. The audit found that DeMamiel Creek's current rates are competitive and the current fee structure reflects industry rates and value for similar golf course services in the region.

Snow Event

A significant snow storm hit the Capital Region between February 8-12.. SEAPARC is pleased to acknowledge the crew of staff that kept our facility operating through the weather. It took a major team effort with staff supporting each other and rising to the challenge when things got difficult.

The District of Sooke has engaged a consultant to identify opportunities to improve pedestrian accessibility and safety on Phillips Road between SEAPARC and Sooke Road. The SEAPARC Manager took part in a discussion on the topic with District of Sooke, Sooke Museum and EMCS representatives on January 23, 2019.

2018 Surplus

The SEAPARC Manager reported a 2018 Operating Budget surplus of \$162,000.
