a) West Coast Wonder Women International All Female Boxing Tournament

As directed by the Commission at their October, 2019 meeting, the SEAPARC Manager reported on discussions with Sooke Boxing Club regarding their request to hold a boxing tournament on the arena dry floor June 26-28, 2020 at a reduced rental rate. In recognition of the value of this international event to the community and the non-profit status of the Club, the Manager proposed a graduated rental rate plan for the period 2020 to 2024 with increases each year until regular full rate reached in 2024.

Staff are reviewing a new grant opportunity in partnership with West Shore Parks and Recreation, Sooke School District 62 and Island Health. This grant will focus on furthering our joint efforts in improving the community's physical literacy and health and wellness through inclusive programming, policies, and services.

Specifically, the grant would include training, education and awareness for staff and community members, as well as securing a small portable equipment trailer, equipped with supplies that can be used at various community events to promote physical literacy and enhance social connections. The grant will include costs for staffing, supplies, promotion and renting a small trailer that will transport equipment. This trailer will also act as a tool for promoting SEAPARC and the PLAY Sooke Westshore committee at community events, expanding our reach into the community.

ADMINISTRATION

Weather Event

The week of January 13, 2020 brought significant stormy weather to the Sooke region. This storm packed a major snowfall punch of approximately 30cm. SEAPARC staff worked hard to maintain basic service levels and kept the facility open and operating for the community. A big thank you to the SEAPARC team for keeping the facility operational during this difficult time.

Fitness Equipment

Fitness Experience was selected as the successful supplier of fitness equipment for the new gym through the CRD procurement process. The final award for PRECOR commercial fitness equipment totaled \$207,600. The equipment has begun to arrive and final installation is expected to be completed shortly.

"Tow and Collect" Equipment

The CRD received a Community Work Funds grant through the Juan de Fuca Electoral Area to purchase specialized equipment that removes goose feces from playing fields, golf courses and parks. The machine is towed and brushes rotate picking up waste. It has a 4-foot wide pickup path and 130 gallon catching hopper. This equipment will be used to provide relief from the current goose feces problem in Sooke. SEAPARC staff are working with the Sooke Community Association on developing an agreement to ensure this equipment is mobile and provides the maximum benefits to the community.
