2023 funding allocations discussion: Housing recommended as primary issue to focus on for 2023. \$64, 582 total unallocated funds for 2023.

MOVED by Commissioner Piskor and **SECONDED** by Commissioner Goldman that the SGI Community Economic Sustainability Commission request the CRD Board carry over



\$31,620 from the 2022 fiscal year into the 2023 fiscal year, to be allocated to GL 503130 (Contract for services).

MOVED by Commissioner Piskor and **SECONDED** by Commissioner Goldman that the SGI Community Economic Sustainability Commission request the CRD Board carry over 50% of any surplus from the 2022 budget to 490000 and 50% to the operating reserve fund 105547 towards 514060 (Program Development). **CARRIED**

5. SGI Liaisons Update – Justine Starke/Liaisons

Emma Davis (Galiano) there are struggles within the community to meet housing and living needs. Food bank visits have increased. There is a new mental health worker on Galiano now.

Kat Ferneyhough (Mayne) similar to Galiano, housing crisis is ongoing, food bank is lacking staff so has reduced operating hours.

Justine Starke (CRD) transitioning between terms with the new board, working on contract renewals for various services and work programs.

Documents defining the roles of the Neighbourhood House and Community Resource Centre and the programs and services they provide was presented to the Commission. Charitable status is being sought for the Neighbourhood House by March 2023.
