Ben was over two days ago on Miners helping us with the power washing. A couple of us were down there doing some of the work and he just pitched right in. Being engaged as commissioners and experienced people give us a much better understanding of the facilities, which helps us to lower our engineering costs. So, I'd like to see us move more towards that direction in the future.

5. PRESENTATIONS/DELEGATIONS

There were no presentations or delegations.

6. COMMISSION BUSINESS

6.1. Southern Gulf Islands Harbours Projects and Operations Update – April 2023

The Commission received the report for information. There is no recommendation.

Staff provided a summary of the project updates and noted the following additional information:

19-01 | Anson Road – Substantial completion with certificate of completion.

19-02 | Retreat Cove – Project deferred and to be re-assessed after inspection.

19-03 | Horton Bay – No major concern found during low-tide Inspection on floating portion of the dock. Minor repairs to be done on floats, such as filling holes on pilings Staff members and commissioners to attend the upcoming scheduled meeting in May with Western Canada Marine Response Corporation (WCMRC) regarding equipment containers project. More details to come. Some seasonal turn-over/overflow from Anson Dock will move to Horton Bay in upcoming months.

Commissioner Fenton joined meeting electronically at 9:48 a.m.

20-02 | Spanish Hills – Tripping hazard (bolts sticking out), under transition plate on the ramp on the dock, has been resolved with UHMW (Ultra-high-molecular-weight polyethylene) covering the area and painted yellow line as visual aid.

20-04 | Miners Bay Upgrades – ICE-t application successful for the revitalization project. Funding from ICE-t will be paid upon providing receipts. To create stacking funds and avoid cashflow issue during the project, application for Community Works Funds to be pursued.

MOVED by Commissioner Fenton, **SECONDED** by Commissioner Brent, That Capital Plan for the Miners Bay Revitalization Project budget be amended from \$30,000 to \$90,000, to be funded 100% from grants and donations.

CARRIED

21-01 | Port Washington – Final deficiency walkthrough pushed from April 20th to April 28th. Concerns raised on gaps in the range of 0.5 to 1 inch between the new and existing woods. Disjointed communication resulted in high traffic area (from ramp to float) not prioritized and repaired. Staff to follow up with Salish Sea on quality of work. Plan for Float B (Relocation or removal) to be discussed after inspection of facility is completed.

21-03 | Annual Provision Hope Bay – Float A

Two projects (Float A floatation replacement & Float B stringer) at Hope Bay being

funded by this budget. Approximately \$70,000 remaining in this budget to fund other potential repairs and upgrades. Replacement/improvement needed at transition between Floats A and C. Staff to confirm if this work is included as part of the project scope.

21-05 | **Piers Island** – Has not received response from First Nation per letter sent in January with March response deadline. Staff may attempt in-person visit to further conversation.

22-02 | Swartz Bay – Substantially completed.

21-02 | SGIH Inspections – Request for Proposals in progress.

OPERATIONAL UPDATES

Wharfingers:

- 1) New wharfinger for Lyall Harbour, Vanessa Verbistsky was welcome on board couple of weeks ago.
- 2) Wharfinger openings for Piers Island and Swartz Bay. Peter B. acting as interim wharfinger during this period. Open For Opportunity (OFP) to be put out by the end of April.
- 3) Recent increase reports of issues including theft, people living outside the facility, nearby business found stolen goods tied at CRD facility, at Piers Island. RCMP has been involved. More on-site visits by staff are planned.
- 4) More maintenance items to be determined based on Wharfinger's bi-monthly reports. Items will be funded by Provisional Budget.

<u>SUBJECT</u> Southern Gulf Islands Harbours Projects and Operations Update - July 2023

ISSUE SUMMARY

To provide the Southern Gulf Islands Harbours Commission with capital project status reports and operational updates.

BACKGROUND

The Southern Gulf Islands Harbours (SGIH) service area is comprised of 13 dock facilities among six islands. Through the service's five-year capital plan, the Capital Regional District (CRD) executes capital projects to maintain the level of service, improve service, and conduct major repairs. The following is a summary of the projects that are active and recently completed.

CAPITAL PROJECT UPDATE

19-01 | Anson Road (Complete)

Project Description: Construction of the Anson Road facility - gravel roadway/parking lot, retaining wall, approach, main float and additional moorage.

Project Update and Milestones:

- Awaiting record documentation signoff from Herold Engineering, including confirmation on anchoring of gangway.
- Guarantee Period expires on February 12, 2024.

19-02 | Retreat Cove (Complete)

Project Description: Upgrades to the Retreat Cove Dock Facility to maintain level of service.

Project Rationale: This project includes works to maintain the current level of service as recommended in the Moffatt & Nichol Summary Report for Southern Gulf Islands Harbours Commission (Commission) Facilities December 11, 2015, and Stantec's 2018 top-side inspection. Recommended works include repairs to the approach piles, and repairs to the floats.

- Further investigation to the existing condition has staff determining that this project can be deferred until after the 2023 inspections. This was confirmed with the Wharfinger Coordinator and Galiano Island's Commission member.
- Funds were used in April 2022 for flotation repair, in the amount of \$4,869.50, with the remainder to be returned to the Capital Reserve Fund (CRF).
- Additional work will be reconsidered after the dock inspections are completed and will be under a new Capital project.

19-03 | Horton Bay Dock Revitalization

Project Description: Decommission the Horton Bay dock after construction of the Anson Road facility has been renamed to Horton Bay Dock Revitalization.

Project Rationale: This project was for the decommissioning of the Horton Bay facility after construction of the Anson Road dock. Instead these same capital funds will now be used to revitalize the dock.

Project Update and Milestones:

- The decommissioning of the dock was previously put on hold and is now cancelled.
- The same capital funds will be used to revitalize the dock under the same project number. The Capital Expenditure Type in the Capital Plan will change from Decommission to Renewal.
- Transport Canada and the Province have been informed and in agreement to the revised approach.
- Some minor maintenance has already been completed to the wharfhead and gangway.
- The piles in the floating section of the dock have been inspected at low tide and are in good condition.
- An annual moorage agreement with Western Canada Marine Response Corp. (WCMRC) is executed. This will enable two Transport Canada-certified oil-spill response packages to be stored on the dock without compromising public access. This will assist with environmental protection of the marine environment in the area.
- The dock will remain open to the public.
- The plan is for a set of new or refurbished floats to be installed to replace the existing floats.
- Staff are considering moving Float C from Port Washington and refurbishing it to replace Float A or ' at Horton Bay.
- Environmental and archeological assessments have been previously carried out.

20-02 | Spanish Hills (Complete)

Project Description: Upgrades to the Spanish Hills Dock Facility to maintain level of service, including preventative maintenance works on piles, replacement of broken pile footing and replacement of the gangway and float.

Project Update and Milestones:

• Guarantee Period expires on February 12, 2024.

23-01 | Miners Bay Upgrades

Project Description: Project to replace decking at Miners Bay as well as potentially removing gas lines that are no longer in use.

Project Rationale: Current decking is failing and has been deemed a safety hazard.

Project Update and Milestones:

- Contractors provided quotes for three scenarios to upgrade the wharfhead decking. Prices
 received were over budget and a re-scoping of the works was initiated.
- A grant application to the Island Coastal Economic Trust was successful.
- The Grant is for a maximum of one-third of the project costs. An additional \$30,000 of Community Works Funds has been sourced along with donations from local community groups.
- The works in the grant application include replacement of the decking, as well as adding hand-railings, benches, and a small shelter to benefit the users of the water taxi, float planes, and school taxi. As well as to enable broader community use.
- The removal of the decommissioned gas line may be deferred due to budget constraints.
- The works are scheduled for completion in 2023.

21-01 | Port Washington (Substantial Completion)

Project Description: Dock improvements outlined from the 18-01 Inspections project.

Project Rationale: This project includes works to maintain the current level of service as recommended in Stantec's 2018 inspection. Contracted works include approach and float pile replacements; float improvements, including decking, rub boards, bull rails and aluminum transition plates; and gangway works, including replacement of roller bearings, hinges, and guide rails.

Project Update and Milestones:

- Project was modified consistent with past discussions at the Commission.
- Concerns with wharfhead re-decking was corrected and is now complete.
- The work was substantially completed on April 28, 2023.
- Guarantee Period expires on April 28, 2024.
- Through this capital project, staff are considering moving Float C from Port Washington and refurbishing it to replace either Float A or B at Horton Bay. Float C is considered as surplus to the demand for moorage at Port Washington and is causing additional wear on the other parts of the dock.

21-03 | Annual Provisional: Dock Improvements

Project Description: An annual provisional fund is required to address unplanned dock safety issues.

Project Rationale: Funds are required for unplanned and minor repairs such as minor board replacement, painting, emergency repairs, and electrical repairs.

Project Update and Milestones:

- This is an "as and when needed" project, funds will be utilized when required at each dock facility.
- The Wharfinger Coordinator and Operations Manager are prioritizing small works not covered under existing capital projects for action.
- One additional project at Port Washington dock was added to the project list since the last report.
- Additional projects might be added based on the most recent dock inspection reports.

21-05 | Piers Island Additional Float

Project Description: Installation of an additional float at the Piers Island dock.

Project Rationale: This project is to complete the Piers Island Additional Float replacement. Design, environmental assessment, and majority of permitting is complete. Funds are required to retain a contractor to supply and install an additional float.

- Design and Department of Fisheries and Oceans (DFO) approval complete.
- Ministry of Forests, Lands, Natural Resource Operations (FLNRO) and Rural

Development, and Transport Canada First Nation condition is required for the water lease amendment and for Transport Canada approval.

- Cowichan Tribes previously rejected support for the project, in 2019, based on proximity to traditional harvesting area.
- Letter requesting support sent to Cowichan Tribes March 18, 2022.
- Feedback in support received April 7, 2022.
- ITT for Supply and Installation of new float issued on June 6, 2022.
- ITT for Supply and Installation of new float closed on July 14, 2022.
- Recommendation to Award to Pacific Industrial & Marine Ltd. (PIM) signed August 10, 2022.
- Cowichan Tribes raised concerns about heritage fishing grounds with FLNRO via an email dated August 23, 2022. Waiting to send contract to PIM until this issue is resolved.
- New correspondence was sent to the Chief in Council in January 2023 regarding revisions to the dock design to mitigate concerns, and updated information from the biologist. Continue to wait for a response from First Nations.
- In discussion with PIM, currently they are willing to honor the tender bid pricing.

22-01 | Hope Bay (Substantial Completion)

Project Description: Dock improvements outlined from the 18-01 Inspections project.

Project Rationale: This project includes works to maintain the current level of service as recommended in Stantec's 2018 inspection. Recommended works include approach decking, bull rail, and handrail repair and replacements, float and gangway repairs. Funds are required for staff to retain a contractor to carry out the works.

- The work was substantially completed on June 8, 2023.
- Guarantee Period expires on June 8, 2024.

22-02 | Swartz Bay Improvements & Dock Replacement (Complete)

Project Description: Works include approach decking, bull rail and handrail repair and replacements, float B replacement and gangway repairs.

Project Update and Milestones:

• Guarantee Period expires on February 12, 2024.

21-02 | SGIH Inspections

Project Description: Dock inspection, including underwater inspections, are conducted as periodic reviews of the facilities to determine repair and maintenance requirements.

Project Rationale: This project includes work of an underwater inspection of the dock facilities to be used to re-evaluate proposed work plans and residual life estimates. Subsequent low tide inspections may be conducted as well if budget allows. These inspections will be used to re-evaluate the Five Year Capital Program.

- Scope of work was revised following the February 24, 2023 Commission meeting, such that underwater inspections will only be completed on seven docks that use underwater chain anchors, rather than pilings, to secure the floating portions of the docks. For these seven docks, anchorage systems, underside of floats and pile structures will be inspected underwater using the same technique. Provisional items are also included for inspecting the underside of approaches and wharfheads.
- The remaining docks will have all the pilings inspected during low tides. This will be completed under separate contract and is anticipated to be completed from a skiff or by a person on the docks.
- Topside inspection will be considered based on budget availability, following underwater and low tide inspections.
- A request for proposals (RFP), 2023-857, was issued on April 18, 2023, and five proponents responded on May 25, 2023.
- CRD staff completed a technical evaluation of the responses and only three had their financial submissions opened. Upon completion of the technical and financial evaluations it was determined that Pelagic Technologies (Pelagic) was best qualified to perform the inspections.
- Recommendation to Award was signed by CRD staff on June 23, 2023.
- Contract value with contingency is \$75,000.

Hello

I met you a couple of years ago at the Montague dock when you were soliciting feedback from dock users with respect to the operation of the dock and my experience using the dock as a local property owner. When we met I expressed my concern that owners of relatively large sailboats were being allowed to monopolize the limited dock space at Montague for extended periods of time thus depriving locals, particularly those who have properties on boat access only islands, of reasonable access for temporary moorage.

As you are aware there is very limited dock space at Montagueapprox 100ft on either side of the main finger and the outer T connected to the main finger is reserved for emergency vessels such as ambulance BCH etc. For the majority of the winter there have been two 38ft sailboats rafted on one side of the main finger and an approx 40 ft barge on the opposite side of the finger. In addition, for several weeks an additional 40 ft sailboat was docked behind the two rafted sailboats. By my calculation these 4 vessels have been using between 40 and 60% of the available space on a semi permanent basis. Recently, when I departed Montague there were two sailboats taking up a complete side of the main finger. I understand why these sailboats are there.....they are required to pay about 30% of what it would cost to moor in a commercial marina but in the process they are depriving others of reasonable access. It is not practical to raft to sailboats because of their freeboard. Boats are being rafted 2 and 3 abreast and having myself watched seniors clambering over boats to reach the dock it seems to me to be only a matter of time before someone gets injured. In my humble opinion the rules need to be changed and I am suggesting that it would be reasonable to impose a max 25ft vessel length limit. I think this would go a long way to relieving congestion at Montague and probably also increase user willingness to participate in what is essentially an honour system of payment.

Dear

This message is from some of the members of the Spanish Hills Improvement District. Some of us live here full time and many have had our properties for three or four decades.

We very much appreciate the work that has been done over the past few years to improve the safety and condition of the Spanish Hills pier and dock. I'll refer to the pier as the fixed structure at the top and the dock as the floating portion. The ramp is a particularly great improvement as there were safety issues and incidents at the top and bottom of the previous ramp. The new one is also much easier to use for carrying or rolling goods up and down.

We do have two concerns with the current state.

1. We hope that the railing around the end of the pier can be removed. None of us are aware of any incidents or safety concerns with the lack of a railing there in the past. As you know, the pier is a hub of activity and many people come to jump, swim, hang out, and enjoy the scenery. Group jumping is a popular activity. As soon as the jumping began again on the May long weekend, we saw groups of people jumping from the top of the railing (photo attached). We are concerned about the safety of this. Much less important, but the railing also detracts from the view of the many people who come to sit on the bench.

2. The ladder up to the end of the pier is very old and it has broken off and no longer extends to the water at low tide. This means that people jumping at lower water levels need to swim around to the small dock ladder, which puts them in the way of motor boat activity.

Thank you for all your work taking care of the dock. We hope you consider our suggestions.
