**1. Territorial Acknowledgement**

Welcome to the unceded traditional territories of the Coast Salish peoples, in whose traditional territories we are blessed to live, work and play.

**2. Resource Agencies**

M. Golden, Mobile Youth Services Team provided the following update:

- It is extremely busy. Online sexual exploitation is constant and overwhelming. Youth are being pressured into increasing gang activity and drug trafficking. This is happening in every community.
- Funding is still not secured for MYST outreach team member. VFC&YJC has written an advocacy letter, and CRD's Board has given a support letter. Councils and School Districts are welcome to do the same. M. Golden's funding ends on March 30.

G. Lindquist, Restorative Justice (R.J.) Victoria provided the following update:

- Last year, 71 referrals for youth, 18 offenders under the age of 25.
- 30 percent significantly marginalized and in complex situations.
- Significant increase in sexualized violence.
- RJ is working on a project with Rotary for in-school presentations relating to harm in the school community; large community need for this work.
- R.J. thanked VFCYJ Committee for their support and advocacy and indicated that the committee in the past has been great about encouraging the province to supply stable funding.
