Please be advised that at their meeting held July 8, 2020, The Capital Regional District Board passed a motion that permits the 2020 Annual General Meetings for the Local Service Area committees to be held electronically and to permit the election process for new committee members by way of mail-in ballot.

Member Nominations

Pursuant to Bylaw No. 3511 (A Bylaw for Establishment of the Wilderness Mountain Water Service Commission) owners or occupants in the Local Service Area are invited to submit nominations of members to stand on the committee for the upcoming two year term starting January 1, 2021. Total membership on the committee is four (4); there are two (2) terms expiring on December 31, 2020.

Completed nomination forms (see attached) must be delivered to Capital Regional District, Integrated Water Services by the deadline **September 18, 2020, 4:30 pm**.

Nominations will not be received at the Annual General Meeting scheduled in November.

Personal Information

Personal information collected is in accordance with s.26(c) of the *Freedom of Information and Protection of Privacy Act*, for the purpose of administering the Wilderness Mountain Water Service Commission nominations and election process. Personal information submitted is kept secure and remains strictly confidential.

Nominees

Nominated property owner(s) or occupants(s) within the Service Area will be contacted to provide their written consent prior to proceeding with the election process.

Mail-in Ballots

In circumstances where the number of nominees in the applicable service area equals more than the number of positions available, mail-in ballot packages will be mailed to owners and occupants in the service in October. Detailed instructions on how to vote by mail will be included with the ballots at that time.

In the event of a tie, or where an insufficient number of ballots are received, the Electoral Area Director will appoint members to vacant positions.

Upcoming Notice of Meeting

The meeting for Wilderness Mountain Water Service will be held electronically in November. A Notice of Meeting will be sent by mail to all owners and occupants within the applicable service announcing the time and date of the meetings and provide information on how to participate in those meetings.
