1. Pacific Landing (formerly Essencia)

Ray Parks, former CEO of the Provincial Capital Commission, current trustee with the Pacific Landing Trust:

- no major changes to original Essencia development proposal
- have not spoken with Colwood yet, but plan to soon, and hope to move forward with plans in 2014

2. Interpretive Signs and Mural

Colwood reported that discussions with both Songhees and Esquimalt First Nations both continue to go well. Esquimalt Nation developed a proposal for a ceremony to mark installation, now submitting to Songhees and Colwood for their input. Timeline and details to be announced.

3. First Nations House at RRU (former boat house)

Opening celebrations for Blue Heron House were successful. Staff has been hired to coordinate activities. It is hoped that Darlene Gait's painting created for the First Nations interpretive sign can be acquired for this building.

4. Colwood Development Updates

• Ocean Grove (under new ownership, formerly called Aquattro)
Sea Cliff Development (new owners) spoke with Colwood recently about potential amendment to original site plan, nothing has been received by Colwood. Many of the previous owner's commitments carry forward to new owner, who have said they conducted "community consultation". Local residents present were not aware of any consultation and are concerned with a number of commitments the community and ELSI expects (i.e. sewer hook-up for specific properties, traffic calming along the Coburg Peninsula, Selleck Creek restoration, interpretive centre, Murray's Pond, commitments made to First Nations)

Pacific Landings

Colwood had no further updates

Royal Bay

Currently in site preparation phase as outlined in Master Development Plan and working with the original timeline. Phase 1 – High school is planned to be opened Sept 2015, most likely with single family lots developed as road access is created.

5. DND House on Coburg Peninsula

This was recently demolished and removed. Colwood and DND are talking about the land and remediation options for this site.

6. Coburg Peninsula Memorial Bench Program Review

Currently, Colwood is not considering any new benches. They will work on a case by case basis as they receive requests for memorial benches. ELSI members suggested Colwood staff look into details of the bench program, as plaques were originally intended to remain for a 10 year period. Perhaps plaques could be renewed by original families, or replaced with new memorials.

7. MBS and Off-leash Area Signage and Handouts

Natalie drafted and received ELSI input on flyers that could also be used as stickers on existing garbage cans. ELSI recommends putting signage up directing dog walkers towards off leash area west of the pump station. Discussion followed regarding how to achieve this. Suggested that the proposal be forwarded to Michael Baxter for discussion at Parks Committee and consideration for including this item in 2014 budget request.

8. Broom Control around the Lagoon

Colwood Park on the foreshore of the lagoon at new Selleck Creek channel and wetland is now overrun with very large Scotch broom. ELSI volunteers cannot handle this site. Should Colwood consider using a method that Metro Vancouver is currently using: cutting the main stem and painting with herbicide? Natalie will send a link to a video showing this method. Colwood needs to look at all viable options and follow regulations.

9. Outreach Events, Materials and Website

- 2012 ELSI Annual Update was handed out and will soon be up on the website
- Upcoming new CRD website will continue to host the ELSI website and has updated the website look (keeping original ELSI logo with the addition of "proudly supported by CRD"), along with complementary new templates for outreach materials

2014 Outreach Events

- Speaker's series to coincide with Fort Rodd Hill's events planned to mark the anniversaries of WW 1 & 2. Speakers could include First Nations.
- Art proposal at Pacific Landings: ELSI reviewed the idea/proposal of a local artist to create a
 labyrinth to the southwest of Pendray House. MBS regulations suggest that it should be located
 outside of the MBS which extends behind Pendray House.
- Coburg Peninsula Driftwood Art Event: proposal and discussion led by Cindy Moyer. Proposing
 an event similar to one held in summer 2008, but on a smaller scale and limited to Coburg
 Peninsula. Holding a 2 day event would allow access to potential funding. Activities could
 include driftwood art creation, music, food trucks, celebration of First Nations and the
 importance of the MBS, lagoon, etc. Dates are flexible but not during "Rock the Shores" event.
- Dune Grass Planting: plugs at Camosun College are not healthy enough to plant (watered too much in summer); planting event could take place in Spring or Fall 2014; need to work with David Blundon at Camosun to plan this. Dune grass plugs at Bee Creek greenhouse are doing well

10. CRD Harbours and Watersheds Program

 Natalie had been offered a new position at CRD, so will be leaving her role as ELSI Coordinator this month; position to be posted ASAP

- Harbours Survey results: 740 responses; Esquimalt Lagoon section was handed out; this will
 give us a good idea of how the Esquimalt Lagoon and other harbours are used, what people's
 visions and concerns are for each area
 - Next Steps:
 - 1. Analyze results, create summary report
 - 2. Meeting with municipal staff to review results (Fall 2013)
 - 3. Host several community Open Houses in early 2014

• Water Quality Objectives (WQOs) - sampling results, consultation and drafting

CRD's IWMP continues to work with the provincial government to draft WQOs for the 5 harbour areas. The Harbour Survey and public consultation will provide information to be considered in development of WQOs.

Colwood Creek flow monitoring indicates that Colwood Creek is one of the healthier creeks being studied. Langford's weather station will give us data to align with flow data and will assist in developing discharge rating curves. Summer temperatures in Colwood Creek seem very high, station data does not align with data from years of Community Fish Monitoring. Natalie will check with CRD samplers.

11. 2014 Work Plan

ELSI will continue with regular outreach events, and hopes to work on/with:

- Colwood on dogs-on-leash issues within the MBS
- Camosun College on dune grass planting
- Cindy and Fort Rodd Hill (Matthew) on a potential summer celebration along the Coburg Peninsula
- CRD on providing input to development of WQOs for Esquimalt Lagoon

12. Partner Updates

RRU/Nancy:

- -Group of students will be researching how Regional Districts in the area are dealing with invasive species. They will draft a report to the CRD's Roundtable on the Environment
- -2014 anniversaries: 75th for military college and 100th for Hatley Park
- -roads and trails network is complete, in 2014 work will be done to install culverts for fish passing under Cottonwood Rd. This will also help with flooding issues

Jason: interested in the flow data that is being generated by CRD for Colwood Cr.

Gayle: concerned about the health of the lagoon with the current discoloration in patches and white foam; no report of a "turnover" thus far this fall. The two developments that may start up again in 2014 will have an impact on the lagoon. Jody has had discussions with sampling staff at CRD, we have lots of water quality data and reports, but need an external expert to bring together all the data to make some recommendations. Funding would need to be in place to move forward.

Joe: Continuing with the Community Fish Monitoring. Important to note that we have found cutthroat trout in Selleck Creek. Joe and Beth hosting outdoor kindergarten class there for fish trapping (2nd year)

Beth: Put notice up on ELSI website about ELEA
