Presentation: HandyDART update by BC Transit representatives (Lori Beaulieu, Katie Hamilton, Errol Nordstrom, Geoff Huber, Scott Murdoch, and Cori Barraclough)

- Representatives from BC Transit updated the group on the handyDART project (please contact Lindsey for copies of the presentation, which is a large file)
- Of particular interest to GWI members were changes in the designation of Watercourse 2 (formerly Ditch 2), and opportunities to relocate this watercourse to join Watercourse 1, in order to improve the quality of riparian and instream fish habitat.
- Upcoming technical reports include a Habitat Assessment and Riparian Area Regulation Report that will be circulated and posted on the handyDART website.
- The preliminary site design is underway and will potentially be completed by March, after which time there will be public and stakeholder consultation. BC Transit will be invited to a future GWI meeting to present the preliminary design and receive feedback.
- BC Transit confirmed that there will be an independent environmental monitor on site during construction
- Several GWI members would like to connect with BC Transit staff to provide further information or to collaborate on projects. Specifically:
 - o Yogi Carolsfeld will connect with Cori Barraclough regarding specific instream enhancement opportunities for Craigflower Creek. He also would like to collaborate in the areas of fish use monitoring and environmental DNA studies
 - Dorothy Chambers would like interested representatives from BC Transit to join her on a tour of MoTI water filtration features at Cuthbert Holmes. She will connect with Scott Murdoch.
 - Bruce Bevan would like BC Transit to be aware of Craigflower water flow and turbidity monitoring data that is available online.
 - o Angela Hanes invites collaboration with BC Transit on managing beaver dams along Craigflower.

- Becky presented planned improvements for Cuthbert Holmes Park from the 2015 Management Plan
- The proposed timeline for the work is:
 - Trail relocation and restoration: before mid-March 2021
 - Creek work: mid-August to September 2021
 - Aspen woodland creation: November
- Becky introduced the Curtis Point Ecological Protection and Visitor Accommodation Project, designed to protect the fragile landscape of Curtis Point while providing opportunities for low impact recreational

Angela continues to work with a lawyer to review options for opposing the BC Transit HandyDART facility and will update the group at the next meeting

- Goldstream Hatchery is delivering eggs to Saltspring and Saturna Islands
- PSS forage fish surveys are underway at Esquimalt Lagoon
- The Atkins fish ladder is functioning well, with high levels of water passing through the culvert
- PSS is hosting a virtual auction in late February. Contact Bill if you would like to participate in this fundraiser.

Jacklyn Barrs, WWF

- Jacklyn believes the first Pacific sand lance egg identified since sampling began in 2018 was found recently at Esquimalt Lagoon

Brianne Czypyha, City of Victoria

- A protective fence has been placed at the east side of Gorge Creek
- A new pollinator meadow interpretive sign has been developed

CRD Harbours and Watersheds Program Update:

Jen Tyler


- Caslys Consulting has been contracted to update the CRD land cover classification using orthophoto imagery from 2017 and 2019 and LiDAR data. Other deliverables will include:
 - Riparian model
 - Canopy height model
 - Suitable planting areas
 - Change in canopy cover and impervious surfaces by municipality and watershed.

The project is planned to be completed by June 2021.

- Green Shores level 2 will be offered through UVic by the Stewardship Council of BC.

 - It is a great opportunity if you are interested to soft shore approaches to shoreline development or restoration. Level 1 is a prerequisite but it can be started any time. https://www.bcit.ca/study/courses/renr1720
- Planning for habours intertidal inventory underway. Four band (RGB, NIR), high-resolution (4 cm), low-tide orthophoto imagery was collected last summer. The extent is the intertidal zone with a 50 m buffer to the backshore or to the nearest road. We can look at making it available if it is of interest to any groups.
