# RE: Capital Region Housing Corporation: Exemption from *Property Transfer Tax Act* for local government housing corporations

The Capital Regional District (CRD) requests that its wholly-owned subsidiary, the Capital Region Housing Corporation (CRHC), be specifically included for an exemption under the *Property Transfer Tax Act* [*PTTA*], Section 14(3). Since 1982, the CRHC has provided public housing rentals and development services for the CRD's public housing and land banking function, created by *Letters Patent* (attached). It currently operates more than 1,300 affordable units.

At present, the *PTTA* subjects the CRHC to Property Transfer Tax when acquiring land or property, adding between 3% to 5% to the total cost of each affordable project. Due to high land values, this is significantly impacting the CRD's ability to provide housing at affordable levels.

We believe this is a gap in the legislation or in the interpretation of "regional district" as applied by delegates. Whereas the CRD has been allowed to create a corporation to operate its public housing function by *Letters Patent*, to charge taxes which would not otherwise be available if the function was operated directly by the regional district will directly impact the affordability of public housing.

The CRHC is exempt from taxation under the *Income Tax Act* and is regarded as a municipality for GST purposes. The CRHC should also be considered a regional district for Property Transfer Tax purposes, by legislative change or by delegate interpretation of "regional district" under the *PTTA*.

AND WHEREAS the Regional Board of the Capital Regional District has requested the function of land assembly, housing and land banking, which request has received the affirmative vote of a majority of all the Directors having among them the majority of all the votes, as required by subsection (4c) of section 766:

AND KNOW YE THAT by these presents We do order and proclaim that on, from, and after the date hereof the following be added to the objects, powers, obligations, duties, limitations, and conditions of the said regional district:-

> DIVISION XII - Land Assembly, Housing and Land Banking

1. All member municipalities shall participate and share in the cost of the function pursuant to this Division.

2. The regional district is empowered to undertake land assembly for the purpose of housing, either public or private and, public housing, pursuant to the provisions of the National Housing Act, The Municipal Act of the Province of British Columbia, the Housing Act of British Columbia, and other legislation of the Province of British Columbia pertaining to land assembly and public housing, as if the regional district were a municipality.

3. The annual net cost attributable to this function of the regional district shall be apportioned among the member municipalities on the basis referred to in subsection (1) of section 782 of the Municipal Act. 4. The annual net expenditure of the regional district pursuant to this function shall in total not exceed the product of one-quarter of a mill on the total value of land and improvements within the regional district referred to in paragraph 3.

5. The Regional District Board may by by-law assume the assets, rights, obligations and liabilities for any existing or approved project under the National Housing Act.

AND THAT the Letters Patent incorporating the regional district be amended accordingly.


