I am also writing to invite you and your Councillors to participate in an upcoming 2023 Forum of All Councils. The Forum of All Councils brings First Nations and Capital Regional District (CRD) Board Directors and Municipal Councillors together to build relationships and explore ways to work together. Due to COVID-19, this is the first Forum of All Councils since 2019.

The Forum's proposed theme is **Indigenous Self-Determination** in the context of relationships with local governments. It will be held **on Saturday, October 14th, from 9:00 am to 2:00 pm**, at the Songhees Wellness Centre. We will provide a light breakfast starting at 8:00 am and a catered lunch, and all attendees will receive an honorarium for participating.
