### A Message from your Director

As I look forward to serving the Southern Gulf Islands for the next four years as your Electoral Area Director, I want to extend a heartfelt thank you to our many volunteers who work with community groups and volunteer on Capital Regional District (CRD) Commissions, working with CRD staff to deliver services and projects. Top priorities for me involve continuing to support and take action to address the housing crisis on our islands, transportation needs, and connectivity improvements.

### **Connecting with Islanders**

The SGI Liaison program has become a core resource to connect each of the large islands (Galiano, Saturna, Mayne, and North & South Pender Islands) with CRD programs and staff. Locals on each island are available to connect the community and coordinate with CRD services for CRD projects. The liaisons are my "boots on the ground" who provide information, connect community groups, and facilitate islanders' access to various CRD services. They've also brought unique skills to the table, providing synergy and costeffectiveness to our organization. As well, I'm committed to being open and accessible, and will be making myself available on your island throughout the year.

### Integrated Transportation Planning

The CRD conducted a thorough service review and in-depth community consultation which culminated in the 2022 referendum to create a transportation service on the islands. While the referendum was close but ultimately not successful, I am continuing to consider other ways to support community proposals for transportation solutions despite the lack of a CRD service to hold or provide funding and administrative capacity.

Housing in the Southern Gulf Islands The Southern Gulf Islands has an urgent need to increase housing options for workers, young families, and low income community members. The CRD housing strategy for the Southern Gulf Islands has now been adopted by the CRD. It proposes a rural housing program in recognition that housing needs on the islands are different than in urban centres, and suggests actions for how the CRD can better support solutions that fit the islands. Through the SGI Community Economic Sustainability Commission's work with the Southern Gulf Islands Community Resource Centre, the Housing NOW project has been launched to match those with housing needs with others that have surplus housing to offer.

### Connectivity Planning

Ensuring reliable, affordable internet service continues to be a major focus of the CRD's work in the Southern Gulf Islands. The CRD's partnership with Connected Coast will bring high speed internet to the shores of most of our islands, and last mile fibre solutions to Galiano and Saturna Islands. The CRD is continuing to work with other internet service providers to ensure investments will improve internet on all the islands.

### How the CRD Works

The business of the CRD Board is managed by 24 directors who are elected every four years from 13 municipalities and three electoral areas. Board meetings, open to the public, are held on the second Wednesday of each month at 625 Fisgard Street, Victoria.

CRD service delivery in the Southern Gulf Islands is often done by way of delegated authority to advisory commissions, made up of local island based volunteers who deliver services on behalf of the CRD Board. Examples include the local community parks commissions, the library commission, the Community Economic Sustainability Commission, the SGI Harbours Commissions and individual water/sewer commissions on the islands.

The Electoral Area Director is the area's representative at the CRD Board and on various CRD committees, including the Electoral Areas Committee (EAC), made up of the Directors from each of the three electoral areas. The CRD Board must ratify the recommendations of all committees. EAC meetings are also typically held on Wednesdays and are video-recorded.


