The Capital Regional District Galiano Island Parks and Recreation Commission offers annual funding opportunities to groups and organizations that provide recreational benefits to the residents of Galiano. The Commission currently defines a recreation program as a formally organized community activity for the purpose of amusement or pleasure and is considered "fun". This chosen activity is done in one's leisure or discretionary time.

### All projects must meet the following conditions to be eligible for GIPRC Funds:

- Funding will help remove barriers to participation in recreation.
- Broad in appeal and accessible to the community.
- Offers good value and shows financial viability.
- Inclusive of people of all abilities.
- Helps to reduce social isolation & improve mental-emotional-physical well-being.
- Provides recreational and/or athletic and/or cultural benefits to the
- community. Projects with the broadest benefits will be given priority.
- Includes a plan for GIPRC acknowledgement in advertising/promotion.
- Reports have been submitted for any previous GIPRC funding.
- Submission of a satisfactory and complete application form by April 15, 2024.

Funds can be used to purchase program costs including moveable recreation equipment, operating supplies, room rentals or wages. GIPRC will NOT fund capital projects or upgrades or groups that are not open to the general population for participation.

Eligible groups and projects include, but are not limited to recreation, athletic and cultural clubs, community hall groups, and community events. In the past, GIPRC has provided support to pre-school programs, to activities for school-age children; to the fitness centre for persons of all ages; to sports activities; to continuing education programs workshops and events; to children's summer programs and to community events and recreation activities.
